able to show my face in society. All of them
are very dangerous persons thus I along with
my son, daughter and father-in-law are passing
our life in a serious threat as because they
can even kill me and rape my daughter
at any time. They even snatched my father-in-law's mobile
while he was shooting today's incident.

I therefore pray before you, to please
kindly take immediate legal action against
all of them for ends of justice.
