For your kind perusal, I would further like to intimate you that I have been posted for the same post in the district of Cooch behar also in addition to Siliguri. Unfortunately I had no staff for Siliguri office since 2013, although I had prayed for the staff for several times to look after the office. Moreover, the office remained closed for last two years during Covid-19 (Pandemic) situation as we have not received any order of permission for continuing sports activities from the Hon'ble Govt. But unfortunately a mishap happened oh 16.04.2022 when the windows, doors of the office was found broken and it was clear that someone forcibly entered into the office room and took away every important official documents along with valuables.
