I Miss Priyanka Gupta, D/O Sri Kanchan Gupta, Advocate of Siliguri Bar Association, resident of East Vivekananda Pally, Hemanta Mukherjee Sarani, P.O. Rabindra Sarani, P.S. Bhaktinagar, Dist Jalpaiguri, do hereby like to inform you as follows:

- That I am the lawful owner of one four wheeler vehicle of Hyundai Accent being no. WB73E-6272.
- 2. That on 20/04/2022 at about 11.00 A.M., when my driver namely Sarfaraj Mondal was plying the said vehicle from Ghoramore to rail gate signal where my car was about to proceed after the green signal of rail gate and during that time, one vehicle of Rani Sathi LPG Indane Gas Corporation bearing no WB73E-8399 suddenly thrashed my car from the right side and was trying to overtake my car unlawfully.
- 3. That subsequently due to the above mentioned incident my car got damaged severally and both the right side door of the car smashed. Moreover my driver also got severally injured due to the accident.
