Sir,

With due respect, I am producing herewith 01 (One) arrested accused person namely Krishna Dey (25 yrs) S/O Late Sukumar Dey of D.S. Colony, PS- NJP, Dist.- Jalpaiguri under arrest and 01 improvised small Fire arm (One shooter) measuring 31 cm in length including its 17.5 CM barrel with one trigger, striking hammer, striking pin in working condition loaded with 01 (one) round ammunition. The ground of arrest duly been communicated with him.

I SI Goutam Mallik of NJP PS, SPC do hereby lodge this written complaint against the above noted arrested accused person. In this regard, I beg to report that today i.e. on 22.04.22 at 22:25 hrs I received a secret information that one Krishna Dey of D.S. Colony, under PS NJP, Dist.- Jalpaiguri is moving at NJP Truck Stand under PS- NJP, Dist.- Jalpaiguri with improvised fire arms loaded with live ammunition most probably for committing heinous crime. Accordingly, I Diarised the information in General diary vide NJP PS GDE No 1109 dated 22.04.2022 and informed the fact to you. As per kind order and direction myself along with ASI Khagen Barman, C/1053 Paresh Rava, VP/13 Jamirul Islam, VP/08 Laxman Roy and CV/306 Bisawajit Roy all of NJP PS, SPC left for NJP Truck Stand under PS-NJP, Dist.- Jalpaiguri with investigation kit to work out the information in hand by Govt. vehicle. We reached at the spot i.e. NJP Truck Stand at about 22.45 hrs on 22.04.22 and as indicated by the source we able to apprehend one person. On being asked he disclosed his identity as noted above. As per source information, that he possessed improvised fire arms and ammunition. Hence, immediately I searched the detained person and recovered 01 (one) small Fire arm (One shooter) measuring 31 CM in length with one trigger, striking hammer, striking pin loaded with one ammunition which accused kept concealed in his waist. He exclusively possessed improvised fire arm loaded with ammunition illegally. On demand he failed to produce any document in support the said improvised fire arm and live ammunition which has been found in his possession. Thus when his involvement in carrying and possessing illegal fire arm and ammunition was established, I seized that improvised fire arms and marked as "Exhibit-A" and 01 (one) round of ammunition marked as "Exhibit-B" under proper seizure list duly signed by him as well as by available witnesses between 23:25 hrs to 23:55 hrs on 22.04.22 and arrested him by preparing memo of arrest informing him about the ground of arrest.

Under the above noted facts and seizure of incriminating articles there is strong reason to believe that the said accused person namely Krishna Dey (25 yrs) S/O Late Sukumar Dey of D.S. Colony, PS- NJP, Dist.- Jalpaiguri is desperate and dangerous in nature, as he was carrying the said fire arm and ammunition with an objective to commit heinous crime in the locality.

As he willfully violated the regulation of Arms Act, So, I pray before you for starting a case against the said arrested accused person namely Krishna Dey (25 yrs) S/O Late Sukumar Dey of D.S. Colony, PS- NJP, Dist.- Jalpaiguri under appropriate section of law and arrange for its investigation.
