Sir,

In producing here with the seized articles viz:-

- (i) 02(Two) Indane domestic Gas Cylinder partially loaded.
- (ii) 01 (One) HP domestic Gas Cylinder partially loaded
- (iii) 01 (one) gas pipe length about 05 (five) fit with fitted one gas Regulator.

In producing herewith above seized articles under proper seizure list. I SI Goutam Kundu of Enforcement Branch Siliguri Police Commissionerate do hereby lodge this written complaint against the owner namely Ananda Das S/O Lt. Fanindra Ch. Das owner of Sweet Shop Styled as "Ananda Mistanna Bhandar" at Gate Bazar, Paticolony Road, PS- Pradhannagar, Dist- Darjeeling. Who was illegally procured the domestic Gas cylinder at his Sweet Shop styled as "Ananda Mistanya Bhandar" for commercial purpose without any valid documents or license to the effect that today i.e. 21.04.22 at about 13:00 hrs received information from reliable source that one Ananda Das S/O Lt. Fanindra Ch. Das owner of Sweet Shop Styled as "Ananda Mistanya Bhandar" situated at Gate Bazar, Paticolony Road, PS- Pradhannagar, Dist- Darjeeling is using the domestic Gas cylinder at his Sweet shop Styled as "Ananda Mistanya Bhandar" for use commercial purpose for his wrongful gain.

Accordingly the matter informed to ACP EB SPC and as per his direction I, along with, SI Pardip Chakraborty, C/924 Avijit Kar, CV 539 Kousik Mondal all of EB SPC with investigation kit left for Pradhannagar PS vide EB SPC M.C.C No 46/22 Dt.21.04.2022. The matters informed to Pradhananagar PS vide Pradhannagar PS GDE No. 1395 at 14:05 hrs Dt.21.04.22 along with K- 30 van officer ASI Suresh Kami, C/836 S. Chhetri, C/880 S. Dutta of Pradhannagar PS vide Pradhannagar PS MCC No 1130 /22 Dt.21.04.22 had been to Gate Bazar, Paticolony Road, PS- Pradhannagar, Dist- Darjeeling to work out the information and apprised them about the information in hand and requested them to accompany with us during search and seizure. As per source identification we reached at the shop styled as "Ananda Mistanya Bhandar" situated at Gate Bazar, Paticolony Road, PS- Pradhannagar, Dist- Darjeeling and entered into Sweet Shop "Ananda Mistanya Bhandar" at mentioned address and found worker of Sweet Shop by using the domestic Indane Gas cylinder without any valid documents for commercial use, on demand they could not produce any valid documents in support of using the Indane domestic gas cylinders for commercial use. Further local enquiry it is revealed that the above noted accused person was using the domestic Indane gas cylinder for preparing Sweet items at his Sweet Shop as a commercial use for his wrongful gain without any valid document. I also managed independent witness namely (1) Raju Ghosh (42) S/O Lt. Debendra Ghosh of Paticolony 2 no. Road, PS- Pradhannagar, Dist- Darjeeling (2) C/ 924 Avijit Kar of Enforcement Branch SPC.

The owner of the Sweet Shop namely Amanda Das used the domestic Indane gas cylinder abundantly for commercial purpose. Subsequently I seized the above-noted articles from possession of his son namely Deepjyoti Das (19) S/O Ananda Das Gate Bazar, Paticolony Road, PS- Pradhannagar, Dist- Darjeeling in presence of witnesses after preparing proper seizure list and label. The seizure was made in between 14:45hrs to 15:05 hrs in presence of witnesses. But found the owner of shop Amanda Das is absconding from the shop to evade police arrest.

Hence, I pray before you a specific case may kindly be started under proper section of law against the accused person Ananda Das S/O Lt. Fanindra Ch. Das owner of Sweet Shop Styled as "Ananda Mistanya Bhandar" situated at Gate Bazar, Paticolony Road, PS- Pradhannagar, Dist- Darjeeling and arrange for its investigation.
