Respected Sir,

I, Mr. Rishav Gupta, Son of Sri Ram Kumar Gupta, resident at Nivedita Road Gurung Basti, Ward No.3 of SMC, Police Station: Pradhan Nagar, Siliguri, District: Darjeeling, in the State of West Bengal, would like to request you for your kind information and necessary action as follows:-

1. That I am the registered & recorded owner of all that piece and parcel of land measuring 5.50 Decimals within Mouza: Kalkut, J.L. No.44, Pargana: Patharghata, B.L. & L.R.O. Matigara, Police Station: Pradhan Nagar, Siliguri, District: Darjeeling, in the State of West Bengal by virtue of Deed of Sale vide Document No.1-2621 for the year 2022 recorded in the Office of A.D.S.R. Siliguri-II at Bagdogra from one Gopal Chandra Das, Son of Late Prakash Chandra Das of Pradhan Nagar Siliguri.

That in the midnight dated: 20-04-2022 some antisocial persons namely 1.Ujjal Singh son of Puran Singh, 2.Rahul Mahato S/o Not known reside at Devidanga, Champasari P.S. Pradhan Nagar with the help of 10 to 15 unknown antisocial person of the localities as their associate came to my aforesaid landed property and stolen the tin sheet approx 30(Thirty) piece & bamboo 20(Twenty) piece as fencing attached with outer of brick boundary wall of my said landed property, and also looted valuable goods and also Cement, Rod, 4(Four) CCTV Camera, 1(one) DVR HISKVISION vide No.DS(7104HGHI)E1(553101144) along with Hard Disk, 1(one) SUPERNET Company WIFI ROUTER, 1(One) electric meter vide No.GE0079674 in running condition of WBSEDC, 4(Four) Halogen Light. Etc, and also damaged my property approx amount of Rs.2,00,000/-(Rupees Two Lac) and they are searching me intentionally for my murder purpose but they did not found me and they fled away. When I knew from my reliable sources then immediate came in my said landed property and shocked from that incident.

So, under the above circumstances I therefore request you kindly enquire the matter immediate and recorded this complaint as F.I.R., and do such necessary legal action against the said accused person namely **1.Ujjal Singh, 2.Rahul Mahato** and their associates 10 to 15 unknown antisocial person of the locality as per provision of law. And also save me and my property from their wrong intension and recover the said looted items from their custody. For this I shall always oblige you.
