Respected Sir,

With due respect I, Sri. Rajib Dutta, S/o Bijoy Dutta, of Collage Para, Near Water Tank, P.S. Siliguri, Dist-Darjeeling, would like to draw your kind attention to the following effect that I got married on 27.11.2014 with Rumki Das Dutta, as per Hindu Rites and Customs without any sort of dowry at Swapna Neel Bhawan Hakimpara, P.S. Siliguri and after marriage one male child was born on 5.10.2017 namely Rajdeep Dutta. I am resides with my parents, wife and son at my aforesaid address since the marriage my wife used to torture us in various manner and she did not perform her marital duty and had no respect towards my parents as well as me and she also forced my mother to cook every day for all persons, however she used to quarrel with my mother, it is pertinent to mention that we have a cosmetics shop at Bidhan Market, as a result I along with my father after 10 A.M. every day after breakfast at that time my mother was alone in my aforesaid address and my wife maximum time passed in her elder sister's house i.e. Soma Das at Pritilata Apartment, Hakimpara, P.S. Siliguri, Dist. Darjeeling, wherein my mother in law and husband of Soma Das also resided there. The aforesaid persons always threatened me by putting fear of 498A case by saying that arrange to transfer our said residential accommodation in my wife's name by my parents and also quarrel with my married elder sister viz Debjani Ghosh and her husband Susanta Ghosh so as to they are not able to enter into our house, ultimately on 11.4.2022 at around 5/7 PM my said wife Rumki Das Dutta forcibly pored poison /insecticide (Tafgor) in the mouth of my mother to kill her with the conspiracy with the aforesaid persons i.e. her sister and Jamaibabu in absence of us and thereafter fled from our house and took shelter in her sister 's house and my mother called me and my sister Debjani Ghosh through her cell phone being no. 9775842365 to our phone 9733266920 and 9593911837 by saying that she is feeling uneasy because my wife forcibly poured poison in her mouth and fled from there as a result I immediately rushed in our house at that time my didi and jamaibabu also came there and found my mother Jaya Dutta was vomiting with lying condition and also some smell (Jhajhalo) noticed by us then immediately didi, Debjani Ghosh and her husband, Sushanta Ghosh and our some relatives called by us took my mother in S D Hospital Siliguri wherein attending Doctor admitted her but next day for better treatment her at Paramount Hospital at Khalpara Siliguri, presently she admitted therein in critical condition at ICU and her condition is detoriating day by day BIPAP is going on and cannot speak properly. Presently my wife resided in our house with my child but she is very adamant arrogant and never visited Hospital and Nursing home to see my mother some unintentional

delay appeared to lodge this complaint due critical condition of my mother and also public disgrace.

In view of above you are requested to take proper legal step against the aforesaid persons as per law.


