I ,Sri Suman Sarkar , S/O- Late Sunil Kumar sarkar Assistant Engineer & Station Manager ,WBSEDCL, Siliguri Town CCC under P.S. Siliguri empowered by the Electricity Act 2003 (Amen mend Act 2007) do hereby lodged this complaint against Rabindra Prasad , resident at George Mabard Road ,Bidhan market ,near Hotel Embassy for committing unauthorized use o f electricity U/S 135 1(a) & 138 1(b) of the Electricity Act read with Amen mend Act 2007 as stated here under.

On 20.04.2022 I, Sri Suman sarkar along with Sri Malay Goswami, D.E (S& LP) , Pranab Sikhder SO (S & LP) , Sri Subhadip Biswas ,Sr. O.E. Siliguri Town CCC Conducted one surprise checking at Shoe Shop at George Mabard Road ,Bidhan market ,near Hotel Embassy siliguri on 20.04.2022 at about 01.45 P.M.

During inspection theft of electricity was detected U/S 135 1 (a) & 138 1(b). The Present user Rabindra Prasad, S/O Late Bhim Lal Prasad was using electric power from deemed Meter No B2160079 which has given in the name of Bhim Lal Prasad (Late). Details process of theft is enclosed with INSPECTION report.

As theft of Electricity was detected during inspection in our presence and also presence of Rabindra prasad, Present user bearing meter serial number B2160079 (Deemed Connection) and inspection team requested to Rabindra Prasad who has been presence of the place of occurrence to become seizure witness. So I seized the above meter in presenting seizure list in presence of Sri Malay Goswami, D.E (S& LP), Pranab Sikhder SO (S & LP) , Sri Subhradip Biswas ,Sr. O.E. Siliguri Town CCC and duly signed by the witnesses and taken into my custody. Copy of seizure list was handed over to the above said accused person.

Thereafter I along with my team left the premises.

The accused person noted above committed offence U/S 135 1(e) Electricity Act 2003 and amendment Act 2007.
