I, Sri Suman Sarkar, S/O- Late Sunil Kumar sarkar Assistant Engineer & Station Manager, WBSSEDCL, Siliguri Town CCC under P.S. Siliguri empowered by the Electricity Act 2003 (Amendment Act 2007) do hereby lodged this complaint against Sanjay Gupta commercial premises at Monarch Restaurant & Lodge, Sevoke road, near Sevoke more for committing unauthorized use of electricity U/S 135-1(e) of the Electricity Act read with Amendment Act 2007 as stated here under.

On 20.04.2022 I, Sri Suman sarkar along with Sri Malay Goswami, D.E (S & LP), Pranab Sikhder SO (S & LP), Sri Subhadip Biswas, Sr. O.E. Siliguri Town CCC Conducted one surprise checking at Monarch restaurant & Lodge, Sevoke Road siliguri on 20.04.2022 at about 02.45 P.M.

During inspection theft of electricity was detected U/S 135-1 (e). The accused person Sanjay Gupta was using electric power for commercial purpose (Lodge) from LT service Meter No L441895 which is given for residential purpose in the name of Smt. Koushalya Devi. (Details process of theft is enclosed with INSPECTION report).

As theft of Electricity was detected during inspection in our presence and also presence of Sanjay Gupta, Present user bearing meter serial number L441895 and inspection team requested to Sanjay Gupta who has been presence of the place of occurrence to become seizure witness. So I seized the above meter in presenting seizure list in presence of Sri Malay Goswami, D.E (S & LP), Pranab Sikhder SO (S & LP), Sri Subhadip Biswas, Sr. O.E. Siliguri Town CCC and duly signed by the witnesses and taken into my custody. Copy of seizure list was handed over to the above said accused person. Thereafter I along with my team left the premises.

The accused person noted above committed offence U/S 135-1(e) Electricity Act 2003 and amendment Act 2007.
