I (Abhijit Chakraborty) S/O - Sri, Lt. Purnendu Chakraborty, Permanent resident of Vill+Post - Bholardabri, PS - Alipurduar, Jagadish Bose Sarani, Near Nabin Club, 2 no Assam Gate Dist - Alipurduar - 736123 and Present resident of Cosmos valley, A block, Flat No - 2F, BSF road, Near Salugara Bazar, Siliguri, PS - Bhakti Nagar, Jalpaiguri - 734008, here by, raising a complaint against

ARNAB CHOWDHURY (mob-9647790729) and ARITRA CHOWDHURY (mob-8350004269) AND FAMILY residing at ward no 47, ramkrishna colony, Pradhan nagar, Siliguri, Dist - Darjeeling - 734003,

Basis, They have taken from me a total amount of Rs. 466150/- to start a restaurant business Named as BANGALIR BHURIBHOJ placed at : Amtala road, Ward no - 14, Hakim para, PS - Panitanki Out post, Near Amtala Club, Siliguri, Dist - Jalpaiguri - 735101. this has been started since 1st December 2021 and with a partnership agreement.

I have made all the transactions through UPI on the name of ARNAB CHOWDHURY and have all the transactions recorded.

According to the Partnership deed, I am supposed to get 50% on net profit but till date I have not received any amount and neither any account statement has been showed to me. while asked, every time they have showed excuses and even since beginning till date, I am only paying the rent for the space as well as they refused to pay such.

Additionally, they have taken Rs. 50000/- to start a tiffin service under the same brand of BANGALIR BHURIBHOJ with "MANOKAMNA BUILDERS" from me, while enquired, I came to know that since August 2021, MANOKAMNA BUILDERS have canceled the orders due to behavioral issue with BANGALIR BHURIBHOJ, same has been confirmed by their Admin team.

On 15th April, They have also stolen away one Gas oven, Gas cylinder, Microwave, Generator from the business place and since then, have not opened the restaurant as well.

Hereby, requesting you to take necessary legal action against ARNAB CHOWDHURY and ARITRA CHOWDHURY and FAMILY as they all were jointly running this operation of fraudulent act and also requesting you to accept my written complaint against them.
