SUB: Lodging of First Information Report against Smt. Maitreyee Chatterjee, wife of Sri Subrata Chatterjee, resident of beside Gour Abasan, 69, Satyajit Roy Road, Suryanagar, Dabgram, P.O. Rabindra Sarani, P.S. Siliguri, District: Darjeeling.

I, the undersigned, inform you as follows:

1. That I used to reside with my son namely Sri Subrata Chatterjee, daughter-in-law namely Smt. Maitreyee Chatterjee and my granddaughter, in a flat beside Gour Abasan, 69, Satyajit Roy Road, Suryanagar, Dabgram, P.O. Rabindra sarani, P.S. Siliguri, District: Darjeeling and the said flat was purchased by my deceased husband during his life time in the name of my abovenamed son.
2. That my daughter-in-law namely Smt. Maitreyee Chatterjee abovenamed inflicted immense cruelty and torture upon my said son and thereafter drove my son away from the said flat and since the month of July, 2021 my son started to live separately, but I continued to stay in the aforesaid flat alongwith my said daughter-in-law and granddaughter.
3. That during my such stay and in the absence of my said son, my abovenamed daughter-in-law started to torture upon me both physically and mentally on regular basis.

Be it mentioned herein that my daughter-in-law namely Smt. Maitreyee Chatterjee abovenamed furthermore used to snatch away the entire amount of pension from me which I used to receive being the nominee of my dear deceased husband and such extortion of pension continued from me each and every month. She also forced me to give her few of my valuable gold ornaments.

Subsequently she started to confine me in a room and lock it from outside and did not provide me with proper food on account of which I became weak and feeble.

4. That thereafter two months ago my abovenamed daughter-in-law forcibly ousted me from the said flat without allowing me to take any of my belongings which are still under her custody and since then under compelling circumstances I am residing in my relatives house at Deb Villa, Bharat Nagar North, P.O. Rabindra Sarani, P.S. Siliguri, District- Darjeeling.
5. That owing to aforesaid horrifying incident I was traumatized and as a consequence thereof I was not in a position to lodge a complain against my said daughter-in-law, soon thereafter.
6. That even after living separately from my said daughter-in-law, since few days, she is continuously threatening me to give her my entire pension every month and also pressurizing me to transfer my securities in her favour, else, she warned me of tagging into false criminal cases and injure me in life and limb.
7. Above all she assaulted me and through me out from some residence being a senior citizen my age is now 67 years.

In the above circumstances, I most humbly request you to take appropriate legal action against my abovenamed daughter-in-law namely Smt. Maitreyee Chatterjee according to law and save me from suffering further loss and injury.
