Subject - F I R against SAMSER ALI & MD. ASIRUL

Respected Sir,

I, SMT. KHUSBU BARAILY LOHAR, W/o. Mr. Binoy Kumar Lohar, resident of Sukanta Nagar, Upper Bagdogra, P.O. & P.S. Bagdogra, District Darjeeling, in the State of West Bengal, India, would like to state that two (2) persons namely (1) SAMSER ALI, S/o. Md. Loiddin & (2) MD. ASIRUL, S/o. Late Jalaluddin both R/o. Ramkrishnajote, P.O. New Rangia, P.S. Matigara, District Darjeeling executed an Agreement for sell for selling of the below schedule land. That all matters of the said land was handed by these two persons. As per the Agreement I paid Rs.3,50,000/- (Rupees Three Lakhs & Fifty Thousand only) to SAMSER ALI & MD. ASIRUL on 24/01/2018. The money amounting to Rs.3,50,000/- (Rupees Three Lakhs & Fifty Thousand only) was also received by SAMSER ALI & MD. ASIRUL by putting their signature on the Agreement. Later I came to know that the actual owner of the land is Sri Basanto Kumar Sahu, S/o. Late Babu Lal Sahu, R/o. Matigara, P.O. & P.S. Matigara, District Darjeeling. The abovenamed persons could not give possession of the below schedule land from the actual recorded owner of the land to me and hence after repeated request and continuous phone calls they again executed a Agreement dated 2/12/2018 and returned Rs.80,000/- (Rupees Eighty Thousand only) and promised to pay the balance amount of Rs.2,70,000/- (Rupees Two Lakhs & Seventy Thousand only)

within February 2019. Now they are not giving the money and are lingering the matter and giving me date after date to pay the amount. I am being harassed by this person and now I strongly believe that have intentionally cheated me only for money.

It is requested before you to kindly take necessary action against SAMSER ALI & MD. ASIRUL, so that they can be punished for harassing me unnecessarily and I can get back the hard earned money.
