Dear Sir,

With due respect I the undersigned would like to inform you that, yesterday i.e. on 21.04.2022 at about 07:30 P.M. my husband Sri Kishore Ghosh, son of Kumar bhanjan Ghosh came out from our house along with my fourteen years old daughter and at the junction point of Bidhan Road and Raja Rammohan Roy Road, near a tea stall basically known as "Naresh Tea Shop" and at that time some persons were assembled there. I would like to further inform you that my husband requested the said persons to leave the way and talk at the foothpath at that time, one person namely, Tinku Saha son of Anil Saha resident of Chayanpara, P.S. Bhaktinagar, dist. Jalpaiguri who is running a tea stall in front of our house suddenly started to use filthy languages towards my husband and my daughter and on protest, said Tinku Saha threw boiling water from a kettle on the face of my husband and thereafter he also threw hot boiling milk on the body of my husband and at that time my daughter started to shout to call for help and for saving the life of my husband from grip of Tinku Saha who was tightly holding him from his collar but it is more horrible when said Tinku Saha brought one metal pan and hit my husband with it on his head and immediately blood started to ooze out from his head.

I would like to further inform you that seen the said incident, my daughter started crying and shouting and after hearing the loud noise I rushed to the place of incident and found that my husband was lying on the road and in unconscious state and blood was coming out of his-head. Thereafter the said Tinku Saha eloped from the place of incident when jthe local people started to gather there.

I would like to further inform you that finding my husband in such critical condition, I took him to the Emergency of the Anandoloke Multi Speciality Hospital and the attending doctor after examining him, prescribed few medical examinations and medications and also administrated injection and also stitched his head and also mentioned in the medical prescription in injury details as "5 cm Linear cut injury over Lt parietal region. Bone Deep" and my husband also sustained severe burn injury and blisters started forming on his face and other parts of body where the boiling water and milk were thrown. The attending doctor also requested my husband to get admission as his condition was very serious and critical but as my susband was concerned about the safety of me and our minor
