I, Md. Taubid (50) s/o Late Md. Mubid Khan, resident of ~~Queresti Mohalla~~, (Near Dr. Rajendra Prasad Girls High School), Deogipara, Ward no. 6 SMC, P.O. Siliguri, Bazar, P.S. Siliguri, Distt. Dejally, beg. to inform you that on Dt. 21.04.2022 at about 02:30pm, when my son namely, Md. Morukhan (30), went to drink Lassi at Vivekananda Road in the shop of Mr. Dhapan and Naku and drink one glass of Lassi and paid Rs. 200/- note, but when they denied to returned Rs. 190/- then to my son and started abusing him filthy languages, then my said son called us namely (1) Karmal Nisha (60) w/o Md. Nasirul Khan (2) Sajda Khatun w/o Chand Khatun (3) Sobi Khatun (17) D/o Md. Sherif Akter (4) Md. Chand Khan (34) s/o Md. Nasirul Khan (5) Sajina Khatun (35) w/o Md. Hora Khan (6) Samir Khan (16) s/o Md. Sadik Khan (7) Md. Gmran (10) s/o Md. Nazim all are of Queresti Mohalla, Deogipara, Distt. BSMC, P.O. & P.S. Siliguri, Distt. Dejally, and we protested with said shopkeepers, then said (1) Dhapan (2) Naku (3) Kajal (4) Nazma (5) Farveen (6) Tamanna (7) Marjina, (8) Manu, all are of Near Bazar & Koka Niketan, Queresti Mohalla, Ward no. 6 SMC, P.S. Siliguri, started beating us with fist & blow and my son namely (1) Morukhan (30) & my daughter-in-law namely (2) Sajda Khatun (33) w/o Md. Chand received severe injury on their persons and immediately shifted to Siliguri Distt. Hospital and my said son Munna Khan admitted there & still under treatment. They have also threatened us for dire consequences.

So, please take necessary action against (1) Dhapan (2) Naku (3) Kajal (4) Nazma (5) Farveen (6) Tamanna (7) Marjina, (8) Manu, all are of Queresti Mohalla, Ward no. 6 SMC, P.O. & P.S. Siliguri (mob. 8597968101 & 8612024452, 22/04/22)
