With due respect I Smt. Taru Roy (Barman), W/o. Dhananjay Roy, presently residing at Fokdoibari, Near Hatiadanga High School, P.O Ghoghomali, P.S Bhaktinagar, Dist. Jalpaiguri, would like to inform you that I have entered into the marriage with **Dhananjay Roy**, S/o. Subal Roy resident of Baniakhari, Tripali Jote, P.O Himul, P.S Matigara, Dist. Darjeeling on 30.06.2013 according to Hindu Rites & Customs at my residential house.

I would like to further inform you that at the time of marriage, my widow mother, my elder brother and three sisters have given cash of a sum of Rs. 40,000/- (Rupees Forty Thousand) only alongwith gold ornaments 30 gms., (one gold chain, one gold male finger ring, one gold female finger ring, two pair ear rings), a motorcycle (Hero Honda Glamour), One Steel Show Case, One Steel Alna, One Dressing Table, One Steel Khat, Kasha (Brass) Dish 9 Pcs, Kasha Bati 3pcs, Kasha Glass 4 pcs, Pital Ghati 2 pcs, One Colour Television, Two sets plastic chair, Shari 12 pcs, Suitcase 1 pcs, Stand Fan 1 pcs, quilt, blanket, pillow and other necessary articles as per the demand of my husband and his family members.

I would like to further inform you that, after my marriage my husband bring me in his house situated at Baniakhari, Tripali Jote, P.O Himul, P.S Matigara, Dist. Jalpaiguri and we have started to live together as husband and wife. After elapsing of just 2 to 3 days my mother in law Smt. Krishna Roy has started to misbehave with me, she told me that my mother and brothers are belongs from the beggar family and I am black and it is for their shame incident to introduce me as their bride, even my father in law **Sri Subal Roy**, my mother in law **Smt. Krishna Roy**, my brother in law **Ranjay Roy**, my sister in law **Smt. Dipa Roy** and her husband **Subodh Roy**, and another sister in law **Smt. Puja Roy** have

abused me filthy languages and they told me that if their son entered into the marriage elsewhere, then they will get handsome dowry and the quality of products which my family members have given all are very low quality, and most of every day they used slung languages upon me and my family members and each and every day my husband and his all family members have together torture upon me by physically and mentally.

I would like to further inform you that, on 16.04.2014 I gave birth of a female child and after the birth of said new born baby girl, my husband and his all family members refused to accept myself alongwith my daughter as because they wants a son from my womb but due to girl child they have started to neglect me and my daughter even after the birth of my daughter my husband and his parents denied to see the face of my daughter and thereafter my mother bring me in her house and after staying 2 months there my husband taking back me and my daughter in his house.

I would like to further inform you that, I have been tortured each and every day since long on the other hand my husband maintains an extra marital relation with one **Anamika @ Mallika Roy**, when I knew the said relation and on asking about the said relation to my husband, he used to beaten me mercilessly and one occasion my husband refused to serving food me and my daughter for 5 continuous day and my husband told me that he shall not allowed the food until I accept their illegal relation and finding no other alternative I accept the illicit relation of my husband just to saving my daughter's life and my husband and his family members always pressure me to bring money from my mother, even my husband is regular alcoholic and gambler, and for playing cards he pressurized upon me to give him money, for playing cards he have already sold many more things from my room like table fan, stand fan, gold ring etc.

I would like to further inform you that on 01.11.2015 my husband started to beaten me and my daughter, and then I have lodged a complaint against my husband and his parents before the O.C. Matigara P.S and on the basis of the said complaint O.C Matigara P.S has started a case under section 498 a of I.P.C. being Matigara P.S Case No. 685/2015 dated 02.11.2015 and after institution the said case my husband got arrested in the said case and thereafter he got bail from Siliguri Court.

I would like to further inform you that, thereafter I have filed a case for maintenance for me and my daughter and after receiving the summons from the court, my husband and his parents came to my house and accept their guilt and thereafter he bring me and my daughter in his house, and on good faith I voluntarily withdraw the said maintenance case from siliguri court but after withdrawing the said case my husband thrown out me and my daughter and then I have started to reside with my mother and brother and after thrown

out my husband entered into second marriage with the said **Anamika Roy @ Mallika Roy** and presently they have stay together in my matrimonial house.

I would like to further inform you that, on 13.04.2022 the date was fixed for evidence before the Ld. J.M. 4th Court at Siliguri in connection with said earlier criminal case and on that day I personally appear before the said court for adducing my evidence but due to non appearance of the conducting lawyer of my husband and his parents the case was adjourned and I return back in my paternal house.

I would like to further inform you that, on 18.04.2024 at about 10 p.m. my husband came to my paternal house and started to threaten me to withdraw the said case otherwise he will kill myself and suddenly he put one pillow on my face and for that scuffle I sustain injury on my severe parts of body and my husband failed to success in his mission when my family members resist them and he left the said place and at the time of leaving the said place he told me that if try to take any legal action I alongwith my daughter and other family members will face its consequences.

Under the above circumstances I would like to request you to take a legal action against the illegal act of my husband and his family members and do needful for the ends of justice.
