I Mukund Agarwal S/O Sri Prem Chand Agarwal, residing at Himachal Sarani, Haiderpara, near Bhara kumara Asram P.S. Bhaktinagar, Dist – Jalpaiguri, I would like to inform you that on 19-04-2022 at about 10:30 P.M to 11:00 P.M when I was brutally assaulted by above name accused persons with sharp cutting weapons causing life risk to me wherein I was sustain sever injuries including cut injuries in my left hand and upper portion of right eye, assaulted was coupled with first and uncountable slap. It is right place to mention that the entire incident took place as I demanded the gold ornaments and cash Rs 6,00,000/-(six lakhs) which I had entrust to my wife for safe custody and later she had handed over the same to her mother without my knowledge and as I pressurized her to hand over the ornaments and cash to me she become arrogant and started abusing and assaulting me and was fully supported by her family members .As this gold ornaments approx 80 gm and cash has been misappropriated by the above mentioned accused persons with some ill motives. This said gold ornaments were made by my hard earned money for my better future and if required to secure quick financial assistance i.e. medical assistance or to purchase a residential accommodation. It is also to be mention here that I have been mentally and physical touture by my mother-in- laws along with others, some anti-social are try to ruin my life and they also threaten me that they will implicate me in some false case and will also take away my children and ruin their life, if i oppose or take any legal steps against them. It is also to be mentioned here that I was admittted in Nursing Home wherein the attending Doctor didn't advice me to go home but due to school of my childrens I voluntary took the discharge from the nursing home. Therefore it is request to you please do the needful and recover the gold ornaments by taking proper legal action.
