Pradhan Nagar for physically assaulting me and disrobing the modesty of my wife Shila Sahani and for snatching my money and gold chain.

Respected Sir,

I Sri Bechan Sahani, son of Late Jogi Sahani, of Khudiram Colony, BRI, Ward No. 1 of S.M.C., P.O. & P.S. Pradhan Nagar, would like to inform you that on 31.03.2022, when me and my wife Shila Sahani along with my two friends namely Sandip Mahato and Deep Mahato had went to attend a invite at the home of Bindeshwar Mahato of Khudiram Colony, BRI, Ward No. 1 of S.M.C., P.O. & P.S. Pradhan Nagar, at around 2.30 P.M. where suddenly the above named person namely Sanjoga Sahani, Mukesh Sahani, Rukesh Sahani, Arun Sahani, Kailash Mahato, Mamta Mahato, and Raj Kumari Mahato, without any reason wrongfully restraint me and wife and when by seeing this two of my friends namely Sandip Mahato and Deep Mahato protested against it and tried to recover me and my wife from their hands suddenly Mukesh Sahani brutally assaulted


me with a sword in the back side of my waist and tried to kill me and Rukesh Sahani, Arun Sahani, Kailash Mahato, teared the saree of my wife with an intention to disrobe the modesty of my wife and Sanjoga Sahani and Mamta Mahato, kicked me and my wife by falling us in the middle of the road and hited us with lathi and bamboo stick and my two friends Sandip Mahato and Deep Mahato were also being assaulted by them when they tried to recover us from their hands, in the mean time the passer by and local residents saw the entire incidents they shouted against them and they run away, thereafter my wife Shila Sahani and my friends Sandip Mahato and Deep Mahato they admitted me in the Siliguri District Hospital in a very serious condition due to loss of blood, at around 4.00 P.M.

It is pertinent to mention here that I am a thalaseamia patient and I need blood in every month. And due to the loss of blood in the aforesaid incident its heavily affected my health condition. That on 1.04.2022 I was discharged from Siliguri District Hospital where Doctors out there had instructed me to take complete bed rest and after coming home I again on 03.04.2022 went and get admitted to Terrai Lions Blood Bank, for taking blood, where doctors said me to take complete bed rest for two weeks that during this course of time me and my family members didn't get time to file a complaint against the above named culprits, but one of them namely Sanjoga Sahani to meet to their illegal motives had lodged a false complaint against my son Chandan Sahani before the pradhan nagar police station to harass me and my family without any reason.

That after the said incident today at around 5.00 P.M. when I am going for a work at my friends home the above named Sanjoga Sahani, Mukesh Sahani, Rukesh Sahani, Arun Sahani, Kailash Mahato, Mamta Mahato and Raj Kumari Mahato again wrongfully restraint me and snatched my money amounting to Rs. 55,000/- (Rupees Fifty Five Thousand) only and snatched my gold chain weighing 10 grams and physically assaulted me and again and threatened me if I will try to lodge any complaint against them they will kill my entire family and will rape my wife.

Under the above circumstances failing no other alternatives and in fear of my life and life of my family members I am writing this complaint against Sanjoga Sahani, Mukesh Sahani, Rukesh Sahani, Arun Sahani, Kailash Mahato, Mamta Mahato and Raj Kumari Mahato all are resident of Khudiram Colony, BRI, Ward No. 1 of S.M.C., P.O. & P.S. Pradhan Nagar, for physically assaulting me with sord and lathi and bamboo stick and for disrobing the modesty of my wife Shila Sahani on 31.03.2022 and again for wrongfully restraining me and assaulting me today i.e. on 23.04.2022 and snatching my money amounting to Rs. 55,000/- (Rupees Fifty Five Thousand) only and snatching my gold chain weighing 10 grams. In this respect I would like to request you to take action against them so that I and my family members could leave our life independently without fear of any one.
