Sir,

With due respect, I Latifa Khatun D/o Md. Sarifuddin, resident of Pachkalguri, P.O & P.S - Matigara, District - Darjeeling, would like to inform you that on 6 - 4 - 2022 I have lodged my FIR to the effect that on 31 - 3 - 2022 at about 8.50 p.m when I was in my house at that time I hear hot attraction going on in between one Md. Md. Jaidul S/o Akbar Ali resident of Pachkalguri, P.O & P.S - Matigara, District - Darjeeling, with my younger brother Md. Ajimul and after hearing said hot altercation, I had been to the place of incident and after seeing me, firstly the said Md. Jaidul pushed me to go away but when I have tried to save my brother, the said Md. Jaidul caught hold my hand and forcefully embraced me with his chest and touched my private part to outrage my modesty and when I started screaming to save my modesty and upon my alarming hue and cry when the local residents started gathering, the said Jaidul with intention to kill me has started pelting stone /bolder upon me and on my house with threatening to face serous consequences.

I then and their made my verbal complaint to the owner of the Sofa Company which is just situated in front of my house in which the mother of Md. Jaidul is working with a hope that the owner of the Sofa Company shall do the needful, so I could not lodge my FIR within time. On 14 - 4 - 2022 I have made my complaint to Police Commissior for the said incident.


So requesting you are hereby again requested to investigate the matter and take necessary legal action against the said Md. Jaidul so that I can live peacefully in my house for the interest of justice.
