Sir,

I SI Md. Sanaullah of Matigara P.S, SPC do hereby lodge a Complaint to the effect that on 25.04.2022 at 14:05 hrs I received a information from my reliable source that one vehicle bearing Reg. No. WB - 59/7111 loaded with stolen river bed materials coming from Fulbari Patan Side . On receiving the information I along with available force rush to the spot to work out the information. Under information and kind order of O/C Matigara P.S on arrival at Fulbari Patan under Matigara P.S area, I found one vehicle bearing Reg. No. WB - 59/7111 loaded with river bed materials going towards Matigara area. Subsequently, I managed to stop the vehicle but the driver of the vehicle fled away from the area. As such, I seized the above noted loaded vehicle under proper seizure list U/S- 102 Cr.P.C in presence of available witnesses as stolen recovery property loaded river bed materials and brought to the above noted bricks at P.S.

Therefore, I pray before you a specific case may kindly be started against the owner / driver of the seized vehicle bearing Reg. No. WB - 59/7111 under proper section of law and arrange for its investigation.
