with 2 Sim cards and criminal trespass at night

Respected Sir,

I, Rina Kumari Ram, D/O - Raj Balom Ram aged about 23 years residing in Sitabpara Siliguri Jalpaiguri, Dist - Jalpaiguri. The incident took place when I was sleeping in my room. On 23/04/2022 I woke in late morning around 11:00 AM, and saw my Phone was not there in my room. I searched the entire room but it was not found. I had an android 'Red Me Note 8 Pro' with blue cover on it that had contained all the necessary and useful information and contacts. The IMEI NO. of my phone is 866566041450 209. When I checked the last location of my phone, I found it was switched off around 8:56 AM morning in my nearby house. Usually, I wake up on 8:00 to 8:30 AM daily but that day I woke up on 11:30 AM and was also having headache. The Person in whose home my phone's last location was found is an habitual offender and a professional thief. His name is Gobind Basak aged about 32 years. After committing criminal trespass by entering into my home at night when I was in deep sleep, he stolen my phone and then he sold it to Satyajit Chhetri aged about 31 years who recollects has started taking drugs and with Gobind Basak as it is confirmed by the people of my locality. The fact of stealing the phone was accepted by Gobind Basak as well as the purchase of the same by Satyajit Chhetri was also accepted by his own Mama, that on the very day of my phone's last, Gobind Basak has sold it to Satyajit which is confirmed my Satyajit's Mama Jaydeb Sarkar age 38 years. Satyajit's mama Jaydeb has admitted this fact to Anand Sarkar who has been witnessed by Police enquiry officer that


Satyajit has purchased a Red ME Phon from Gobind
Bosak in 3000 Rs. When asked by enquiry officer
I admitted this fact to police officer as well that
I has stolen the phone and sold at the Satyajit chhetri.
Also, I have a strong feeling that I was sprayed in my
leeping condition by the the Gobind Bosak because
whenever any sound comes, I immediately respond but
not day I was in deep sleep and also having headache
was not able to wake up. Earlier also the presence
of Gobind Bosak with Satyajit chhetri on 23/04/22 around
morning was accepted by his own cousin sister Kajal
Halder as she also witnessed this that both of them
were roaming around my house, and after completion of
their motive he returned to his room in which he
takes drugs and keeps all the stolen things as witnessed
by Kajal Halder.

Sir, I have a humble request to you
Please take some necessary actions against him, as
my entire life and career is based upon my phone.
I have complete faith on our Police force and
Criminal Justice system.
