I, SI Goutam Mallik presently attached with NJP PS under your kind control beg to state that today i.e. on 25.04.22 at 18.05 hrs I received a secret source information that one person namely Rajib Roy of Tinbatti Colony, PS- NJP, Dist-Jalpaiguri is selling ID liquor illegally at his tea stall at Tinbatti More under PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 1249 dated 25.04.22 and informed the fact to you. As per your kind direction and instruction myself along with C/1053 Paresh Rava , VP/08 Laxman Roy, VP/13 Jamirul Islam and others all of NJP PS, SPC left for Tinbatti More, PS- NJP to work out the information in hand. At about 18.25 hrs we arrived at Tinbatti More and being identified by the source I held raid at the tea stall of the said accused and managed to apprehended him. During interroghation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his tea stall since long for his illegal gain. On search the above noted I/D liquor recovered from his tea stall. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his tea stall. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest.
