With due respect, I am producing herewith the arrested accused persons namely (i) Sanjoy Saha (20 yrs) S/O Late Chaitanya Saha of Santipara, PS- NJP, Dist- Jalpaiguri (ii) Subhankar Dutta (24 yrs) S/O Bapi Dutta of Michel Madhusudan Colony, PS- NJP, Dist- Jalpaiguri (iii) Ajit Roy (25 yrs) S/O Ganga Roy of Michel Madhusudan Colony, PS- NJP, Dist- Jalpaiguri and and the following articles under seizure :-

1. One iron made sharp cutting weapons called as Hasua from the possession of accused Sanjoy Saha S/O Late Chaitanya Saha of Santipara, PS- NJP, Dist- Jalpaiguri
2. One iron made sharp cutting weapons called as Bhojali from the possession of accused Subhankar Dutta (24 yrs) S/O Bapi Dutta of Michel Madhusudan Colony, PS- NJP, Dist- Jalpaiguri
3. One sharp cutting knife and one torch light from the possession of accused Ajit Roy (25 yrs) S/O Ganga Roy of Michel Madhusudan Colony, PS- NJP, Dist- Jalpaiguri.

I, SI Goutam Mallik of NJP PS, Siliguri Police Commissionerate beg to state that on 26.02.22 at 00.15 hrs received a secret source information that that a gang of miscreants come at near 70 More, PS- NJP, Dist- Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Basundhara Abasan Area. Accordingly, I diarised the fact in General Diary vide NJP PS GDE No 1266 dated 26.04.22 and informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC about the information in hand. I also informed the fact to night RT Van officer SI Shib Shankar Das and ASI Amal Debnath and requested them to come to 70 More to accompany with us. At 00.45 hrs we arrived at near 70 more under PS- NJP, Dist- Jalpaiguri. After a few time RT Van officer SI Shib Shankar Das and ASI Amal Debnath along with force came to near 70 More and accompany with us. At about 01.05 hrs as indicated by the source we noticed that 09/10 persons assembled in a dark place near 70 more, PS- NJP, Dist- Jalpaiguri and they were whispering in a very low voice. Accordingly, we cordoned the place properly and approach towards them very slowly and carefully but seeing the police party they started to flee away but we the police party managed to apprehended 03 (Three) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted.

During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presene in middle of the night with deadly weapons. Finally they disclosed that they assembled there for committing dacoity at Basundhara Abasan Area. Accordingly, I seized the above noted weapon of offence from their possession under proper seizure list and arrested the above noted 03 (Three) accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to NJP PS. The search seizure and arrest made in between 02.05 hrs and 02.55 hrs on 26.04.22.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Sanjoy Saha (20 yrs) S/O Late Chaitanya Saha of Santipara, PS- NJP, Dist- Jalpaiguri (ii) Subhankar Dutta (24 yrs) S/O Bapi Dutta of Michel Madhusudan Colony, PS- NJP, Dist- Jalpaiguri (iii) Ajit Roy (25 yrs) S/O Ganga Roy of Michel Madhusudan Colony, PS- NJP, Dist- Jalpaiguri and arrange for its investigation.
