That I Raj Kumar Paswan ⁽⁶¹³²⁾ S/o of Late Ramji Paswan R/o Gram Dimdima P.O.-Salugara P.S.-Bhaktinagar Dist-Jalpaiguri would like to report you -

1. That my son Rambilas Paswan, daughter-in-law namely Radha Paswan W/o Rambilas Paswan and grandson namely Rohan Paswan S/o Rambilas Paswan stay in the same house but separately.
2. That the land where we stay is registered in the name of my wife Ram Sundri Paswan.
3. That my son don't maintain us with food, cloth and other expenses moreover my son, daughter-in-law and grandson coerce us at every moment.
4. That on 02.02.2016 my son Rambilas Paswan daughter-in-law namely Radha Paswan W/o Rambilas Paswan and grandson namely Rohan Paswan S/o Rambilas Paswan assaulted me and my wife with axe and threatened us that they will kill me if I and my wife don't transfer/register the land in their name.
5. That again on 14.10.2016 my son Rambilas Paswan daughter-in-law namely Radha Paswan w/o Rambilas Paswan and grandson namely Rohan Paswan S/o Rambilas Paswan assaulted us and threatened us to transfer/register the land to them which I and wife is repeatedly denying to do so.

7. That again today my son Rambilas Paswan daughter-in-law namely Radha Paswan W/o Rambilas Paswan and grandson namely Rohan Paswan S/o Rambilas Paswan assaulted me and my wife with axe and strangulated me with gamcha but I was saved as my wife managed to release me from their grip.
8. That following the incident they assaulted my wife badly and were threatening us to face dire consequences to death if me and wife don't transfer our property in their favour.

Henceforth we are in the state of utmost fear and we are afraid that they may create more troublesome situation for us and our life. It is a humble prayer before you to kindly take strict action against them.
