I, Najaruddin Ali, S/o. Late Nizamuddin, R/o. Quarter No. KPI/48, Bengdubi, P.O. Bengdubi, P.S. Bagdogra, District Darjeeling, Pin-734424, West Bengal, INDIA, would like to state that on 25.12.2021 at about 6.00 P.M. my father namely Nizamuddin was on his way in his Motor Cycle bearing No. WB 74 AX 6968 from Upper Bagdogra to Bengdubi and at that time he was hit from back side by a unknown vehicle near JOC Bungalow Gate, Apna Gaon, Bengdubi. Due to the said accident my father sustained serious injuries and he was lying at the main road. Some unknown persons saw my father lying at the road and they admitted him to North Bengal Medical College & Hospital and informed us through my father's mobile phone.

I and my family members reached at North Bengal Medical College & Hospital and shifted my father to Paramount Hospital, Siliguri and from there to Nightangle Hospital, Phansidewa More for better treatment where he died due to serious injury on 02-01-2022. The doctors declared him death. At the time of accident I was at my home. As I was in mental trauma and was not aware hence I didn't lodge any FIR before the local Police Station at the time of accident. I was delay in lodging FIR due to mental trauma & ignorance of law.

It is therefore prayed before you to take necessary action.
