Sir,

I, Suman Sengupta, Son of Ashoke Sengupta, D.E & SM Power House CCC, empowered by The Electricity Act 2003 amended on 2007, do here by lodge this complaint against Sri Ananda Mohanta S/O Lt Nitai Chandra Mohanta, resident of Bhupendranagar, Salugara, Siliguri, P.S Bhaktinagar, Dist Jalpaiguri.

On 26.04.2022, the undersigned received an information regarding un authorized alteration of service in Bhupendranagar area behind Vega Mall. On reaching the site it was found that the service wire of Sri Mohan Paul (ph- 8609866219), S/O Krishna Paul, resident of Bhupendranagar, P.S, near Krishna mandir, Salugara, Bhaktinagar, Dist Jalpaiguri having Meter No G120704, was lying disconnected from the PCC Pole, and a new service wire was laid for reconnecting to the meter. The terminal seal of the meter was found broken. On Enquiring regarding the same, Sri Mohan Paul reported that he had paid Sri Ananda Mohanta a sum of Rs 1000/- to change the service cable On 26.04.2022. As there was a problem the service cable, Sri Mohan Paul had approached Ananda Mohanta after he had said that he was employed in Power House CCC, WBSEDCL, Which is false. At around 2.30pm on 26.04.2022, while execution of the un authorized work two contractor workers were passing by the area noticed the un authorized activity and stopped the work.

A written statement regarding the same has been collected from Sri Mohan Paul regarding the incident and is being attached along with this FIR.

Thus you are requested to kindly initiate an investigation against Sri Ananda Mohanta S/O Lt Nitai Chandra Mohanta under Section 138 (1) (a) of the Indian Electricity act 2003 amended on 2007.
