That after our marriage we live together as Husband and Wife at South Colony, N.J.P., P.O.&P.S. Bhaktinagar, Dist. Jalpaiguri and out of said wedlock a male baby was born on dated 20.12.2016 who was presently aged about 6 (six) years namely MD. JAMAL and now staying with me at my above mentioned paternal house at Naxalbari.

That after our marriage (6 months) I had been inflicted mental and physical injuries upon my husband without any reason but I bear all tortures upon considering the future else after born my baby my said husband's habit of inflicting physical and mental tortures upon me mounted up day by day and under the influence of liquor he went one step ahead by, beating me in front of the eyes of my father & mother in-law as a result they strongly protest him but he shamelessly ignored day by day though I tolerated all those tortures with a hope that he will realize everything but such hopes did not come in reality due to my husband was a habitual drunker also a characterless person as because he has illicit relationship to several women and they live together in different cities such as Delhi, Mumbai etc. which was he proudly stated me as such he fled away to Mumbai and left me and my child alone on dated 06/07/2021
