Laxmi Dey, Brother-In-Law Sri Krishna Saha for committing the offence of mental and physical cruelty, attempt to commit murder, domestic violence etc. due to non-fulfillment of demand of further dowry.**

Respected Sir,

With due regards, I, **SMT. ARCHANA SAHA (DEY SARKAR)**, Wife of Sri Jiban Saha, Daughter of Sri Sadhan Chandra Dey Sarkar, Presently residing at Juhuri, Talma, P.O. Talma, P.S. Kotwali, Dist. Jalpaiguri, would like to lodge this written complaint before you to the effect that my marriage was solemnized with **SRI JIBAN SAHA**, Son of Late Naresh Chandra Saha, Resident of Paschim Bhaktinagar, Ward No. 34 of S.M.C., Siliguri, P.O. Bhaktinagar, P.S. N.J.P., Dist. Jalpaiguri, on 28.11.2013, according to the Hindu Rites and Customs, after observing all formalities on and from my parental house as mentioned aforesaid. At the time of my marriage, my parents and other family members have given so many valuable articles like golden ornaments, furniture & fixtures, utensils, clothing's and other valuables including cash a sum of Rs. 40,000/- only as per the demand of my husband and his family members. After my marriage, my husband brought me at my matrimonial house as mentioned aforesaid where we have started to live and co-habited together as husband and wife and just entering into my step in my matrimonial house, my Mother-In-Law and my Unmarried Sister-In-Law strictly instructed me and my family members that they only allow me in their house as their bride and besides me, they will not allow or to keep any relation with my any family members and they have also restricted me not to use any personal mobile phone and if they desired, they will allow me to talk with my parents only from their mobile phones. Sir, immediately after completion of reception ceremony, my Mother-In-Law and Sister-In-Law came to my room and asked me to handover all my jewelries and other valuables which are "Stridhan" in their favour and as per their direction and also considering my future conjugal life, I have compelled to handover all my jewelries and other valuables to them. After my marriage, I have not passed a single day happily in my matrimonial house and immediately after my marriage, my husband in conspiracy with his entire family members have started to create tremendous torture upon me both physically and mentally on various ways and always shows their dissatisfaction towards the "Stridhan" properties and cash which was given by my parents and relatives to them as per their demand and also asked me to bring more dowry from my parents frequently and sometime, considering my future conjugal life, I used to ask money from my parents on different plea in order to continue my marital life happily. Since beginning, my Mother-In-Law And Sister-In-Law in conspiracy with other in laws members have shifted the entire burden of household works of my matrimonial house upon me excepting to allow me in the kitchen and
