Total 04 (Four) numbers of transparent plastic packet containing Total 1 (One) KG 58 (fifty eight) grams of said to be Brown Suger Marked as follows :-

(i) One transparent plastic packet containing total 253 (two hundred fifty three) Grams of said to be brown suger which was kept inside the right pocket of trousers of accused Abdul Rajjak and marked as "Exhibit-A".

I, SI Goutam Mallik of New Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted 04 (four) arrested accused persons namely (i) Abdul Rajjak (23 yrs) S/O Habibur Sk of Vill- Boro Nalda, PO- Chhoto Nalda, PS- Palasipara, Dist.- Nadia (ii) Masidul Mandal (19 yrs) S/O Safikul Mandal of Vill- Boro Nalda, PO- Chhoto Nalda, PS- Palasipara, Dist.- Nadia (iii) Habibur Sk (40 yrs) S/O Nazrul Sk of Vill- Sankarpara, PO-Bhabda, PS-Beldanga, Dist. - Murshidabad and (iv) Atikul Islam (36 yrs) S/O Mubarak Sk of Vill- Sankarpara, PO- Bhabda, PS- Beldanga, Dist. - Murshidabad to the effect that today i.e on 26.04.22 at about 10.35 hrs received a specific source information that 04 (four) persons were standing at Porajhar More near Mahananda Bridge under PS- NJP, Dist.- Jalpaiguri with huge quantity of Brwon Suger for delivering the same to their designed customers. Accordingly, the matter was diarized in General diary vide NJP PS GDE No 1286 dated 26.04.22 and subsequently informed the matter to you and being directed, myself along with ASI Khagen Barman, ASI ASI Sajal Das, C/1053 Paresh Rava, VP/08 Laxman Roy and VP/13 Jamirul Islam and others all of NJP PS, SPC and a police team of Special Operation Group, Siliguri Police Commissionerate being headed by SI Rash Bihari Saha, ASI Binod Jha and force left for Porajhar More near Mahananda Bridge under PS- NJP, Dist.- Jalpaiguri by Govt Vehicle along with investigation kit to verify the veraciuty of the information in hand vide NJP PS GDE No 1287 dated 26.04.22 and M.C.C. No. 1321/22 dated 26.04.22. Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the consealment of eveicences of facility for the escape of the offender.

On the way to Porajhar More, I contacted two persons namely (1) Kartik Mandal S/O late Falguni Mandal of Porajhar, PS- NJP, Dist.- Jalpaiguri and (2) Biswajit Mallick S/O Late Hari Narayan Mallick of Porajhar, PS- NJP, Dist.- Jalpaiguri and make them aware about the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with the independent witnesses noted above reached at Porajhar More under PS NJP, Dist.- Jalpaiguri at 11.05 hrs and being pointed by the source approached towards 04 (four) persons standing at near Mahandanda Bridge, Porajhar More. At that time seeing the police party approcaching towards them they started to fled away from the spot but however we managed to apprehended them. Thereafter, we disclosed our identity and inform them regarding the information in hand and stated them that
