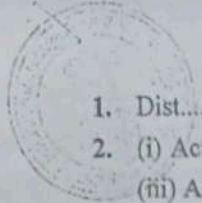

I, SRI CHANU BHAGAT, S/o- Late Gopal Bhagat, Resident of Gopal Apartment, Meghlal Roy Road, Ward No.- XXXIX of S.M.C. Haiderpara, P.O.- Hyderpara, P.S.- Bhaktinagar, Pin.- 734006, Dist.- Jalpaiguri would like to bring to your notice the following facts below:

1. That I am the absolute owner of a piece of land measuring in total of 14 Kathas 10 Chhataks situated at Matigara, Dist.- Darjeeling by virtue of registered Deed of Sale being no. 3341 dated 12-8-97 (hereinafter referred as 'Scheduled land') having absolute title, rights and interest and possession over the same, the details of which is morefully described in the schedule below.
2. That being the absolute owner of the scheduled land I transferred $2\frac{1}{4}$ Kathas out of 14 Kathas 11 Chhataks land by way of Registered Deed of Gift in favour of my daughter namely SMT SUJATA BHAGAT.
3. That since 12-8-1997 I have been in possession of the scheduled land having absolute right, title and interest over the same.
4. That few days ago i.e., on 26.04.2022 some land grabbers (mafias) namely as follows:

Along with some hired goons visited my below scheduled land while some construction work was going on at my below scheduled land and started hue and cry and also started throwing away the construction materials on enquiring the above named miscreants started shouting and using slangs and also told me that I have to leave the below scheduled land at that moment and stop the construction work. Thereafter I protested against their actions and they left the said land and threatened me that if within 1 week I did not leave the below scheduled land me and my family members have to face dire consequences.

That again on 29.04.2022 at around 3.00 pm while I was there at the below scheduled land or its maintenance the aforesaid persons along with some hired again visited the below scheduled land and started pushing me and hitting myself with fists and blows as I was alone their on the below scheduled land.

That I am a senior citizen and a helpless person, the above mentioned miscreants finding myself alone are continuously with and clear intention are conspiring together with an intention to grab my below scheduled land by dispossessing myself from the said below scheduled land which I have bought with my hard earned money.

So, therefore, I being a senior citizen myself humbly request before your goodself to take stringent legal action against the above-named persons and protect and ensure that the my rights in the below scheduled land are protected with an immediate effect in regards to the above stated circumstances.
