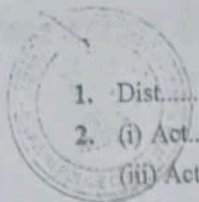

With due respect I SI Uday Chakraborty of Matigara P.S, SPC do hereby lodge this Complaint to the effect that on 30.04.2022 at 03:45 hrs onwards in course of special Mobile van duty along with force detained one vehicle Truck bearing Reg.
