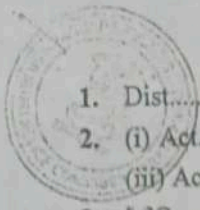

With due respect I ASI Tapan Das of Matigara P.S, SPC do hereby lodge this Complaint to the effect that on 30.04.2022 at 05:25 hrs onwards in course of special Mobile van duty along with force detained one vehicle Truck bearing Reg. No. WB 73 D 1301 loaded with river bed materials at Basbari river Bed near Simultala Ghat violating the Govt. Order. Accordingly, I seized the vehicle bearing Reg.
