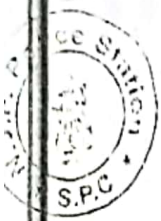

Dear Sir,

With due respect I, **SRI PAWAN KUMAR AGARWAL**, Son of Sri Shivalal Agarwal, resident of Khalpara, Siliguri, P.O. & P.S. Siliguri, District – Darjeeling, would like to draw your kind attention to the following facts which are enumerated herein below in distinct paragraphs -:

1. That I along with my friend Mr. Kailash Agarwal have purchased the total land measuring about 1.65 Acre by the strength of six registered deeds of sale bearing no. 6121 of 2021, 6487 of 2021, 6681 of 2021, 6370 of 2021, 6877 of 2021 and 3122 of 2021 which were registered in the office of the A.D.S.R., Bhaktinagar.
2. That immediately after purchase the land measuring about 1.65 Acre has been recorded in the R.O.R. in our name and two separate Khatians bearing no. 3987 and 3986 have been framed and published under L.R. Plot No. 154, 155 and 156, corresponding to R.S. Plot No. 116, 117, 118 and 119, Mouza – Binnaguri, Sheet No. 17(L.R.), P.S. N.J.P., District – Jalpaiguri.
3. That I along with my friend Kailash Agarwal have been possessing the said land measuring 1.65 Acre with specific boundary. The erstwhile owners transferred the possession of the land measuring 1.65 Acre with specific demarcation and presently the constructional works are going on over the said land. Moreover a tin shed house had already been constructed by the erstwhile owners over the said land and it is now 40 years old structure.
