Sir,

With due respect, I am producing herewith the arrested accused persons namely (i) Pritam Paswan (18 yrs) S/O late Prakash Paswan of Gate Bazar, Shib Shakti Kalibari Road, PS- NJP, Dist- Jalpaiguri (ii) Royal Hussain (32 yrs) S/O Jairul Haque of Jumagachh, Fulbari Hat, PS- NJP, Dist- Jalapiguri (iii) Manik Sarkar (32 yrs) S/O late Gouranga Sarkar of Laketown, PS- NJP, Dist- Jalpaiguri (iv) Rabin Mandal (20 yrs) S/O Nakul Mandal of Paschim Dhantala, PS- NJP, Diast- Jalpaiguri and (v) Biswanath Chakraborty (30 yrs) S/O Gopal Chakraborty of Baribhasa, Madani Bazar, PS- NJP, Dist- Jalpaiguri and and the following articles under seizure :-

- 5 One sharp cutting Knife and one torch light from the possession of accused Biswanath Chakraborty S/O Gopal Chakraborty of Baribhasa, Madani Bazar, PS- NJP, Dist- Jalpaiguri

I, SI Pradeep Diyali of NJP PS, Siliguri Police Commissionerate beg to state that on 29.04.22 at 00.20 hrs received a secret source information that that a gang of miscreants come at near Gora More, PS- NJP, Dist- Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Gora More Area. Accordingly, I diarised the fact in General Diary vide NJP PS GDE No 1422 dated 29.04.22 and informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC about the information in hand. I also informed the fact to night RT Van officer SI Prabir Kr Raha and ASI Raju Subba and requested them to come to Gora More to accompany with us. At 00.45 hrs we arrived at near Gora more under PS- NJP, Dist- Jalpaiguri. After a few time RT Van officer SI Prabir Kr Raha and ASI Raju Subba along with force came to near Gora More and accompany with us. At about 01.15 hrs as indicated by the source we noticed that 09/10 persons assembled in a dark place near Gora more, PS- NJP, Dist- Jalpaiguri and they were whispering in a very low voice. Accordingly, we cordoned the place properly and approach towards them very slowly and carefully but seeing the police party they started to flee away but we the police party managed to apprehended 05 (Five) of them with deadly weapons in their possession. On interrogation the apprehended accused persons disclosed their name and identity as noted above.

During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presene in middle of the night with deadly weapons. Finally they disclosed that they assembled there for committing dacoity at Gora More area. Accordingly, I seized the above noted weapon of offence from their possession under proper seizure list and arrested the above noted 05 (Five) accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to NJP PS. The search seizure and arrest made in between 02.25 hrs and 03.35 hrs on 29.04.22.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Pritam Paswan (18 yrs) S/O late Prakash Paswan of Gate Bazar, Shib Shakti Kalibari Road, PS- NJP, Dist- Jalpaiguri (ii) Royal Hussain (32 yrs) S/O Jairul Haque of Jumagachh, Fulbari Hat, PS- NJP, Dist- Jalapiguri (iii) Manik Sarkar (32 yrs) S/O late Gouranga Sarkar of Laketown, PS- NJP, Dist- Jalpaiguri (iv) Rabin Mandal (20 yrs) S/O Nakul Mandal of Paschim Dhantala, PS- NJP, Diast- Jalpaiguri and (v) Biswanath Chakraborty (30 yrs) S/O Gopal Chakraborty of Baribhasa, Madani Bazar, PS- NJP, Dist- Jalpaiguri and arrange for its investigation.
