Sir,

In producing herewith the accused person Kapil deb Roy (38) S/o Bipin Roy of vill Mohan vita , PO.Mohanvita , PS Rajgang Dist- Jalpaiguri along with the following seized articles viz

- 1. One vehicle (truck) bearing No- WB 73 - 8744 loaded with river bed materials (approx 120 cft.)

I, SI- Prabir Kumar Raha of NJP Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against the driver Namely Kopildeb Roy (29) S/o Bipin Roy of vill Mohanvita , PO Mohanvita , PS Rajganj, Dist- Jalpaiguri. to the effect that on 29.04.22 at 06.05 hrs while performing special mobile van duty vide NJP PS GDE No- 1415 dated 28.04.22 along with C/1041 Kishan Gurung, NVF/0065 Prakash Roy had been to Sahu bridge at the bank of Sahu river and found and found the above noted vehicle bearing no. WB 73 - 8744 , was sand mining within the 100 meter of Sahu river bridge which is violating the lease agreement and was dangerous for Sahu Bridge because of which the bridge could get damage. Accordingly we chase them but some of the person fled away from the spot but we managed to apprehended the driver of the vehicle. On being asked the driver failed to produce any documents in respect of sand mining neither he could produce any documents regarding the ownership of the vehicle. Finding no other alternatives I seized the said truck loaded with sand and arrested the accused driver under proper memo of arrest explaining the ground of arrest.

Hence, it is learnt that the driver of the above noted vehicles bearing no. WB 73 - 8744 was carrying the river bed materials by theft for its clandestine disposal with and act of damaging the Sahu bridge. The seizure was made in between 06.15 hrs to 06.35 hrs.

Hence, I pray that a specific case may kindly be started against the driver of the above noted vehicles bearing no. - WB 73 - 8744 under proper section of Law and arrange for its investigation.
