On routine inspection, I, Suman Sengupta, DE & SM, Power House CCC along with Sanjay Prasad, Sr. O.E., Power House CCC visited the premises of consumer, against Sri Ashwani Kumar Agarwal, Opposite Northern Floor Mills, P.O. Salugara, Siliguri bearing Consumer Id: - 412040555 & Energy Meter No: - L4898315 (Make- Landies & Gyer, 240V, 5-30 Amp. Single Phase) having a Domestic connection. The site being at Opposite Northern Floor Mills, P.O. Salugara, Siliguri. Our representatives entered the consumer premises on 28.04.2022 at 13.25 Hrs. On inspection it was found that the meter was not present physically on the site. The Price of the missing item is Rs 1089/- (approx), other than the actual units consumed and are to be billed yet. We exited the premises on 13.45 Hrs.
