In producing herewith the following four (04) arrested accused persons namely (1) Akash Tamang (27) S/O Palden Tamang of Chowrasta, Tonng Soong, P.S-Sadar, Dist.Darjeeling, (2) Roshan Lama (19) S/O Lt Durga Lama of Baghajotin Colony, Ward No.2, near Radha Krishna Mandir, Ward No.2, P.S-Pradhannagar, Dist.Darjeeling (3) Sushant Rana (19) S/O Sri Sagar Rana of Curung Busty, J.A.C Club, Ward No.3, P.S-Pradhannagar, Dist.Darjeeling, & (4) Sanjay Roy (19) S/O Sri Sadhu Roy of Baghajotin Colony, Nutun Busty, Ward No.2, P.S-Pradhannagar, Dist.Darjeeling, along with the following seized articles:-

- i) One iron made "Hammer" having length "11" CM (approx) including wooden butt recovered from the possession of Akash Tamang
- ii) : One iron made "Karat" having length "58" CM (approx) including wooden butt recovered from the possession of Roshan Lama
- iii) One Iron "rod" having length "27" CM (approx) recovered from the possession of Sushant Rana
- iv) One iron made "Knife" having length "25" CM (approx) including wooden butt recovered from the possession of Bikram Saibo

I, ASI Ashit Singha of Pradhannagar P.S, SPC would like to lodge this written complaint against the above noted accused persons and others to the effect that on 29.04.22 at 00.15 hrs received a source information that 10/12 persons were assembled at Dhaknikata Tea Garden, near Murgi lorai math under Pradhan nagar P.S. area with deadly weapons with a view to commit some heinous crime. Accordingly I inform to you and diarized the matter vide PDN PS GDE No. 1851 dtd.29.04.22 and as per your kind instruction at 00.25 hrs myself along with C/974 Mintu Sen, Cv/223 Swapan Chhetri, CV/128 Ajay Kr Sahani, CV/242 Rakesh Mangar, CV/646 Baban Ch Das, took departure for the spot vide GDE No. 1852 Dtd.29.04.22 We reached near the spot as confirmed by the source and stopped at a considerable distance from above noted spot and we started walking towards the P.O with due care so that no one could anticipate our movement. At about 00.55 hrs and we reached at Dhaknikata tea garden, near Murgi lorai math under Pradhan nagar P.S and found a group of 10/12 persons assembled and gossiping there. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing in multiple directions. Somehow, after a hot chase we could able to apprehend the above noted 04 (Four) persons.

On interrogation they disclosed that they along with other associates with them had assembled there with a view to commit dokoity after making full preparation in a house at adjacent area. Thereafter all the apprehended persons were searched and due to late night I could not find any independent witness to be present at the time of search and seizure. During search the above noted articles were seized from their possession.

All the articles were seized between 01.25 hrs to 02.25 hrs issuing a proper seizure list duly signed by the accused persons. Thereafter all the persons were arrested with proper memo of arrest, and accordingly myself along with force with arrested accused persons returned back at Pradhan nagar P.S.

Under the above circumstances, I pray before you that a specific case may kindly be started against the arrested accused persons namely (1) Akash Tamang (27) S/O Palden Tamang of Chowrasta, Tonng Soong, P.S-Sadar, Dist. Darjeeling, (2) Roshan Lama (19) S/O Lt Durga Lama of Baghajotin Colony, Ward No.2, near Radha Krishna Mandir, Ward No.2, P.S-Pradhannagar, Dist. Darjeeling (3) Sushant Rana (19) S/O Sri Sagar Rana of Gurung Busty, J.A.C Club, Ward No.3, P.S-Pradhannagar, Dist. Darjeeling, & (4) Sanjay Roy (19) S/O Sri Sadhu Roy of Baghajotin Colony, Nutun Busty, Ward No.2, P.S-Pradhannagar, Dist. Darjeeling and other and arrange for its investigation.
