Sir,

In producing herewith one arrested person who disclosed his identities namely Dipak Shil (36 yrs) S/O Late Gopal Shil of Purba Jhar Beltali, Jateswar near Sasi Master School, PS- Falakata Dist- Alipuduar along with the seized articles per seizure list;

1. One improvised iron made 7.65 mm Pistol measuring approx 08.5 inches from barrel to butt having hammer and trigger marked as Exhibits -A,
2. Two rounds ammunition engraved KF 7.65 unreadable on its percussion cap (found loaded in SI No.1 seized exclusively from the possession of accused Dipak Shil) Marked Exhibits-A1.

I, Uday Chakraborty of Siliguri Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against Dipak Shil (36 yrs) S/O Late Gopal Shil of Purba Jhar Beltali, Jateswar near Sasi Master School, PS- Falakata Dist- Alipuduar that on 26.04.22 around 18.45 hrs, received a secret source information that one veteran criminal under Falakata PS, Dist- Alipuduar namely Dipak Shil is roaming at Airview more near Mahananda Bridge under Siliguri PS with an ulterior motive and is in possession of firearms. Dairsed the mater vide Siliguri PS GD Entry No. 1538 dated 26.04.22. As per your kind instruction of I/C Siliguri PS, I along with ASI Subir Sen, ASI Dhruba Misra, ASI Siben Sarkar, CV/622 Ramanath Barman, CV/283 Prosenjit Dey all Siliguri PS rushed to the place at Airview more near Mahananda Bridge area to verify the veracity of this information vide Siliguri PS G.D.E no. 1539 dated 26.04.22. On way I picked up two disinterested witnesses namely (i) Md Sarafat (21 yrs) S/O Idrish Master of Tikiapara, Mazdoor Colony, Ward No. 28, PS- Siliguri, Dist- Darjeeling and (ii) Manjit Singh (30 yrs) S/O Sri Ranjit Singh of Kawakhali, Medical, PS-Matigara, Dist- Darjeeling duly informing them about the information in hand. At 17.05 hrs we reached at nearby Airview more near Mahananda Bridge area and as per description of the wearing apparels supplied by the source, at 18.45 hrs we found that the above noted person is moving suspiciously at Airview more near Mahananda Bridge area. On seeing the police party he tried to escape from the place. But we apprehended the above noted person namely Dipak Shil. On being asked, the apprehended person disclosed his identity as noted above. On further interrogation he admitted that he was in the Airview more with an ulterior motive. Accordingly, as per information and following all necessary procedures of search of the police person by the witnesses, search of the apprehended person Dipak Shil was made on search and found that one improvised iron made 7.65 mm Pistol measuring approx 08.5 inches from barrel to butt having hammer and trigger marked as Exhibits -A along with Two rounds ammunition engraved KF 7.65 unreadable on its percussion cap (found loaded in SI No.1 seized exclusively from the possession of accused Dipak Shil) Marked Exhibits-A1 was recovered from his exclusively possession, which was kept concealed under the Jeans Pant on the left side of the above noted accused person's waist. The ammunition was unloaded from the firearms as per practical experience. On being asked about the possession of the firearms and ammunition, the apprehended Dipak Shil made incoherent statements and failed to produce any valid documents in support of said seized Firearms. As there is every reason to believe that the firearms and ammunitions

recovered has been procured dishonestly by the apprehended Dipak Shil for his ulterior motive, seized and labelled the firearms and ammunition duly taking its measurements and details in presence of the witnesses duly signed by them and acknowledge by the apprehended person and arrested him following all formalities. The seizure and label was made in-between 19.35 hrs and 21.15 hrs. On being further asked the arrested accused person admitted that he came from Jharbaltali, Jateswar under Falakata PS and he was present at Airview more being armed with Fire Arms with an ulterior motive.

Under the above circumstances, I pray that a specific case under Arms Act may kindly be started against the arrested Dipak Shil (36 yrs) S/O Late Gopal Shil of Purba Jhar Beltali, Jateswar near Sasi Master School, PS- Falakata Dist- Alipuduar and arrange for its investigation.
