Sir,

In producing here with the three (03) accused persons namely (1) Raj Guha (18 yrs) S/O Sri Sanjay Guha of Rath Khola near Nabin Sangha Club, Ward No. 22, PS- Siliguri, Dist- Darjeeling (2) Prajawl Limbu (23 yrs) S/O Shyam Limbu of Bragrakot, Jailkhana road near FCI Godown, Ward No. 20, PS- Siliguri Dist- Darjeeling, (3) Abhijit Paul (22 yrs) S/O Ajit Kr. Paul of Hatiadanga near Kali Mandir, PS- Bhaktinagar, Dist- Jalpaiguri under arrest along with seven (07) Bicycles viz-i) One black blue Neon color HERO SPRINT Ranger bicycle having no. JASA06405, ii) one Neon & black color HERCULERS FX100 Ranger bicycle, iii) one black & White HERO OCTANE Ranger bicycle having no. GB17129176, iv) One Persian blue & black color DODGE Ranger Bicycle having No. S11S1483, v) One Red KROSS Ranger Bicycle having no. Y17C7471, vi) One blue Color LAUNCHER Ranger Bicycle having no. 11101 and vii) One Neon Color URBAN TERRAIN under proper seizure list, I SI Uday Chakraborty of Siliguri PS/SPC do hereby lodge this written complaint against the above noted three (03) accused persons to the effect that today i.e. on 26.04.22 at 19.05 hrs I received reliable source information that two persons had assembled at Baghajatin park under Siliguri PS with an intention to sale huge bicycles to the young boys for their wrongful gain, which was stolen one. Accordingly, I diarized the fact in Siliguri PS, vide GD Entry No: 1540, dtd. 26.04.22 and took all informative action. As ordered by superiors, I along with ASI Siben Sarkar, ASI Subir Sen, CV/283 Prosenjit Dey and CV/622 Ramanath Barman left for Baghajatin Park under Siliguri PS with a view to verify the veracity of the information Vide Siliguri PS G.D.E No. 1541 dated 26.04.22.

On 26.04.22 at 19.25hrs we, arrived at Baghajatin Park under PS Siliguri and on seeing the police party the above noted persons tried to escape from the spot. As per identification by source we managed to apprehend the above noted two persons as noted above. On interrogation they disclosed their identity as noted above. On further interrogation the apprehended persons namely Raj Guha and Abhijit Paul confessed that they had stolen different bicycles in different places under Siliguri PS area and stealing bicycles were kept concealed in their partner namely Prajawl Limbu who resides at Bagrakot near FCI Godown under Siliguri PS. Then after I, police party rushed to Bagrakot near FCI Godown under PS Siliguri and held raid at the house of Prajawl Limbu. As per leading statement of apprehended

persons namely Raj Guha and Abhijit Paul, we held a raid in the house of Prajawl Limbu and managed to apprehend him. On interrogation he disclosed his identity as noted above. On further interrogation he admitted that he purchased so many different type of Bicycles from Raj Guha, Abhijit Paul and others since long and sold the same to the young boys for his wrongful gain. On further interrogation all the apprehend persons stated that they had committed this type of offence since last one (01) year. They also stated that they are friends of each other. On demand, the all three accused persons failed to produce any documents in respect of the above noted 07 nos. of Bicycles which were recovered from their joint possession of the three apprehend persons noted above. The all three failed to give any satisfactory account in respect of the registered owner of this bicycle. Neither could they able to mention the name and parentage of the registered owner, nor the permanent address / phone number of the owner. During interrogation, all of them, became perplexed and started giving contradictory statements regarding their inability to produce the documents in respect of the 07 nos. of bicycles. Hence, it is clear that the they have obtained the bicycles by stolen or by any fraudulent means and also received /retained the same in their possession with their knowledge and also assisted in concealing /disposing of the above noted bicycles.

Hence, I seized the above descriptive bicycles in presence of available witnesses duly signed by them. The seizure was made between 20.45 hrs to 21.45 hrs. Then I also arrested the above noted three accused persons after observing all legal formalities and explaining them the grounds of arrest and took them into custody.

Under the above circumstances, I pray to your good self that a specific case under section 411/414 IPC may kindly be initiated against all the three arrested accused persons (1) Raj Guha (18 yrs) S/O Sri Sanjay Guha of Rath Khola near Nabin Sangha Club, Ward No. 22, PS-Siliguri, Dist- Darjeeling (2) Prajawl Limbu (23 yrs) S/O Shyam Limbu of Bragrakot, Jaikhana road near FCI Godown, Ward No. 20, PS- Siliguri Dist- Darjeeling, (3) Abhijit Paul (22 yrs) S/O Ajit Kr. Paul of Hatiadanga near Kali Mandir, PS- Bhaktinagar, Dist- Jalpaiguri and arrange for its investigation.
