In producing herewith one (01) arrested accused person namely Shyam Kumar Yadav (36)
S/O Lt. Rajkumar Yadav of New Pokaijote, PO+PS Pradhan Nagar, Dist Darjeeling (not verified)
along with the following articles under seizure as per seizure list;

1. One iron made improvised one shutter Firearm having its trigger, hammer and firing pin measuring approx 10.2 inch (approx) including its butt, body. [The articles have been found kept concealed on the right side of waist of accused Shyam Kumar Yadav marked as "Exhibit-A"]

2. One live ammunition inscribed as "OK", "02" and "7.2" on its percussion cap found inside the left side pocket of blue color jeans pant of accused Shyam Kumar Yadav & marked as "Exhibit-B"

I, SI Abhishek Theengh, S/O- Sri Suchandra Kumar Theengh of Pradhan Nagar Police Station, Siliguri Police Commissionerate do here by lodge this written complaint against above noted one (01) arrested accused person namely Shyam Kumar Yadav to the effect that today on 30.04.2022 at about 22.15 hrs I received a specific source input that one person is standing near Regulated market under Pradhan Nagar PS, for committing heinous crime. He had carried and possesses small arms & ammunition with him. The matter was diarized vide Pradhan Nagar PS GDE No. 1970 Dt. 30.04.2022. Accordingly, I informed the matter to the Inspector-in-Charge, Pradhan Nagar Police Station. Subsequently, as per his kind direction myself along with ASI Ashit Singh, Const- 762 Mojhibur Rahaman, CV/646 Baban Das, CV/645 Pankaj Das all of Pradhan Nagar PS and along with investigation kit left for Regulated Market by govt. vehicle to verify the veracity of the information. This refers Pradhan Nagar PS GDE No. 1971 Dt. 30.04.022.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter I along with force reached at Regulated Market at 22.35 hrs and being pointed by my source apprehended the above noted accused person named Shyam Kumar Yadav and searched him immediately and found the above noted articles from his conscious and exclusive possession. On demand he failed to produce any document in support of his possessing and carrying of such type of fire arms and ammunitions. Hence, it is evident that the accused named Shyam Kumar Yadav exclusively & consciously possessed this improvised fire arms loaded with live ammunition illegally with some ill motives.

Thus, his involvement in carrying and possessing illegal fire arm is established, I seized and labeled the above noted articles at the spot under proper seizure list duly signed by him and also put my signature on the seizure list and label. The seizure time was made between 22.40 to 23.25 hrs. Subsequently, I also arrested him preparing memo of arrest informing him the ground of his arrest.

From the above noted facts and seizure of incriminating articles there is a strong reason to believe that the accused Shyam Kumar Yadav had carried the said fire arms loaded with live ammunitions with an objective to commit heinous crime in the locality.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Shyam Kumar Yadav (36) S/O Lt. Rajkumar Yadav of New Pokaijote, PO+PS Pradhan Nagar, Dist Darjeeling (not verified) and arrange for its investigation.
