Sub: First Information Report (F.I.R.)

Respected Sir,

I, **Sri Ritesh Mandhyani**, son of Sri Ashok Mandhyani resident of "Siddhi Vatika", Burdwan Raod, P.O. & P.S. Siliguri, District Darjeeling, West Bengal, India would like to bring to your kind notice to the following matters:

- 1. That I am one of the Partner of a Partnership Firm namely "Durong Infra LLP" having its business office at Ektiasal, Eastern Bye pass Road, P.S. Bhaktinagar, District Darjeeling. I along with others Partners of the said Partnership Firm are carrying on the business of different types of Plywood business. I am the active and working partner of the said Partnership business and I use to look after the whole affairs of said business physically and actively attending in the works of the said partnership business.
- 2. That on 10.09.2021 two persons namely Mr. Arbind Tiwary and Dipak Tiwary Partners of a Partnership Firm namely M/S Shanti Enterprise" of Berhampore, 17/18 Kalikpur, Cossimbazar, P.O. &. P.S. Berhampore, District Murshidabad came to our business place and purchased different types of plywood on credit in the name of their said partnership firm namely "Shanti Enterprise" assuring and promising me that they would pay the whole credit purchase price within 25.11.2021 positively without any fail. The total bill of the purchased Plywood was Rs. 5,77,071- (Rupees Five Lakhs Seventy Seven Thousand & Seventy One). It is mentioned here that on their repeated inducement, I sold such goods total wroth Rs. 5,77,071- (Rupees Five Lakhs Seventy Seven Thousand & Seventy One) to them in the name of their said partnership business on credit. They took the plywood from our business Godown on the same date i.e. on 10.09.2021 by loading in a truck being no. WB-76A-4607 with proper purchase Bill, Invoice papers and e-way Bill Date 10.09.2021.
- 3. That out of the aforesaid credit purchase of Rs.5,77,071- (Rupees Five Lakhs Seventy Seven Thousand & Seventy One), Mr. Arbind Tiwary paid total Rs.4,00,000/- (Rupees Four Lakhs only) by three (3) account payee cheque of HDFC Bank being cheque dated 11.10.2021 amounting to Rs.2,00,000/- cheque dated 11.11.2021 amounting to

Rs.1,00,000/- and cheque dated 25.11.2021 amounting to Rs.1,00,000/-). All the three (3) cheque were enchased.

- 4. That after paying Rs.4,00,000/- (Rupees Four Lakhs only) Mr. Arbind Tiwary promised to pay the remaining balance amount of Rs.1,77,071- (Rupees One Lakh Seventy Seven Thousand & Seventy One) within one month. Later after repeated request on 07-02-2022 Mr. Arbind Tiwary issued a cheque in favour of our Firm namely "Durong Infra LLP" vide No. 000021 dated 07-02-2022 of UCO Bank, Berahampur Branch.
- 5. **That** believing on Mr. Arbind Tiwary I took the cheque and deposited the said cheque on 07-02-2022 at Soveko Road, Siliguri Branch in the account of our partnership firm namely "Durong Infra LLP" for encashment but it has come back with the endorsement "**Account Closed**" vide return memo dated 10.02.2022.
- 6. That it is evident from the above that Arbind Tiwary and Dipak Tiwary have no intention of paying the said credit amount and have intentionally cheated me by giving the said cheque of an account which could not be honoured due to reasons best known to them. Arbind Tiwary and Dipak Tiwary deceive me and our Partnership Firm and cheated Rs.1,77,071- (Rupees One Lakh Seventy Seven Thousand & Seventy One) of our partnership firm.
- 7. That I repeatedly requested Mr. Arbind Tiwary and Dipak Tiwary to pay the amount but now it has been more than four months they have failed to pay the same.
- 8. That said Arbind Tiwary and Dipak Tiwary willfully cheated me and committed criminal breach of trust and at present I am suffering from great pain, agony and insecurity.

In such a situation I request you to look into the matter and to take serious appropriate action against Arbind Tiwary and Dipak Tiwary so that they can be punished and I can get back the amount of Rs.1,77,071- (Rupees One Lakh Seventy Seven Thousand & Seventy One). enclosed documents bounce cheque, Invoice cop, hSTIN, Tagde licente, Bank Statements etc.
