One vehicle (truck) bearing No- WB 78- 0731 loaded with river bed materials (approx 225 cft.)

1 S1 Prabir Kr Raha of NJP Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against the driver namely Dilip Debnath (40) S/o Lt. Purna Ch . Debnath of vill Tarejote, Balason, PS Matigara Dist- Darjeeling. to the effect that on 29.04.22 at 04.15 hrs while performing special night mobile van duty vide NJP PS GDE No- 1415 dated 28.04.22 myself along with C/1041 Kishan Gurung, NVF/0065 Prakash Roy had been to Naukaghat at the bank of Mahananda River and found the above noted vehicle bearing no. WB 78-0731 was sand mining within the 100 meter of Mahananda is violating the lease agreement and was dangerous for Naukaghat bridge because of which the bridge could get damage. Accordingly we chased them but some of the person fled away from the spot but we managed to apprehend the driver of the vehicle. On being asked the driver failed to produce any documents in respect of sand mining neither he could produce any documents regarding the ownership of the vehicle. Finding No other alternatives i seize the said truck loaded with sand and arrested the accused driver under proper memo of arrest explaining the ground of arrest.

Hence, it is learnt that the driver of the above noted vehicles bearing no. WB 78-0731 was carrying the river bed materials by theft for its clandestine disposal with an act of damaging the Naukaghat bridge.. The seizure was made in between 04.25 hrs to 04.45 hrs.

Hence, I pray that a specific case may kindly be started against the driver of the above noted vehicles bearing no. WB 78-0731 under proper section of Law and arrange for its investigation.
