I Man Bahadur Chettri s/o of Manika Bahadur Chettri, resident of Upper Johnson Market P.O Sonador PS & Dist- Daryeling would like to inform that on 29/04/2022 at about 22:30 HM to 23:00 HM my son namely Deepankar Chettri (32) while coming out of one restaurant near S17 petrol pump along with his friend namely 1) Pranesh Sonar s/o Teq Bahadur Sonar of Mirik Bazar Ward no 02. P.S Mirik Daryeling & 2) Keshav Ratna Pradhan (43) s/o Gopal Ratna Pradhan of Medhibari Near S17 Siliguri. My son was dashed my some unknown vehicle on National Highway near S17 petrol pump when they were heading to the rented room on foot as stated by his two friends mentioned above. My son was declared brain dead at Siliguri Sarda Hospital and started Siliguri P.S u/D case no. 134/22 dt 30/04/2022. My son was rescued by local people with the help of Police. Mobil Van on duty.

Therefore, I may request you to make and investigation and strict action be taken against person(s) / vehicle who is/are responsible for untimely death of my son as per the law.
