Sub.: Application for lodging FIR against one female friend (name not known), Samiran Sarkar and others.

Sir

With due respect, I the undersigned would like to bring to your kind notice that my son, Amit Kumar Gupta @ Roshan Gupta committed suicide on 09.02.2022 at about 3 am.

That Sir, the incident was reported to your esteemed Police Station and subsequently steps were taken as per prevailing Laws.

That Sir, documents related to his death bears the name Roshan Gupta, which was his nick name. Roshan Gupta and Amit Kumar Gupta be treated as one and identical person and not change in name.

That Sir, due to sudden death of my son, I was not in peace of mind to find the reason for myself behind his this step. After few days, I opened the mobile phone of my beloved son. He used to have two SIMS, bearing Nos - 7076291599 & 7479189252.

That Sir, I noticed some mobile numbers on which several whatsapp and telephonic conversation had taken place. These mobile numbers are (1) 93390 87201 (2) 79085 98973. I could make out that the former belonged to his female friend and later of one Samiran Sarkar.

That Sir, the last call was made from Amit Kumar Gupta @ Roshan Gupta Maternal Grand Father's Mobile No. 8327222778 to 93390 87201.

That Sir, from the whatsapp chat, it appeared to me that my son had an affair with the female mentioned above. To ascertain my doubt, I called up Samiran Sarkar and enquired about my son's female friend. He confessed that my son had an affair with her.

That Sir, I remember once my son had said that he will go on a tour with Samiran, but instead he went with his girl friend. This fact is also confirmed by Samiran to me on mobile. The girl friend of my son must have betrayed him which led him to commit suicide.

That Sir, this may be one reason stated above which possibly made him to commit suicide. I request you Sir, to start the investigation in this case where evidence may be gathered to find out if there are more reason/s or more person/s are involved which possibly made my son bound to commit suicide.

I request you Sir, to open the case, so that the culprits get befitting punishment as per Law and justice is given to the soul of my departed son.
