resident of R.L. Brahman Road, P.O. Substation, P.S. Matigara,
Darjeeling, beg to lodge this complaint as under:-

1) That I am the absolute owner of a plot of land
measuring 5 (Five) Katha recorded L.R. Khata no. 329 in the
part of L.R. plot no I at Harja - Thikrikati, Police station
Matigara Dist Darjeeling.
2) That as in the year 2014-2018 (i) Chander Roy
(ii) Santosh Roy (iii) Shyamal Singh (iv) Jogesh Barman (v)
Rajeshwar Roy Chowdhury and their associates tried to take
forcible possession of my land. I filed a suit for declaration
of perpetual injunction being Title suit no. 71 of 2015
against them in the court of Jd. Civil Judge (Junior
division) at Siliguri.

3) That the Jd. court on 10/04/2015 passed an order of
injunction directing both the parties to maintain
status-quo with regard to the said land till disposal
of the suit.

4) The said order of status-quo is still subsisting and
the suit is pending but Shri Santosh Roy (i) Jogadish
Barman (ii) Jogesh Barman & their associates
violating the "Status Quo" trespassed into my land and
