Siliguri, Distt - Dajeeing, beg to inform you that I am the driver and owner of the E-Rikshaw (INDO WAGEN HEN/566 NO 8703), Sky Blue in colour, bearing chassis no. M162EEC-11819-H0377, Motor No. Z 1201910951, fitted with 4 (four) Numbers of Astral batteries (100 amp X 120 volts each), and I am also work as a member of Catering Party, in the marriages etc.

One Bipan Das S/o Sri Nareesh Das of Shramik Nagar, North Charat Nagar, Ward no. 24 SMC, P.O. & P.S. Siliguri, Distt - Dajeeing who is the head of catering party, and who engaged me and others, to provide catering service in a marriage at Jaiswal Palace, Burdwan Road, Siliguri, and accordingly, I along with other 03 (three) members of the said catering party, reached at Jaiswal Palace, Burdwan Road, driving my said E-Rikshaw and parked it in front of Jaiswal palace on Dt. 27.04.22 at about 09.00 pm, and entered into said Bhawan, along with my co-workers namely, (1) Bipan Das noted above, (Mob. No. 8597768652) (2) Debashis Roy s/o Not known of Bajal-Daha, P.S. N.T.P. Distt - Jalpaiguri & (3) one unknown member of the said catering party, and joined with rest other members of the catering party namely, (4) Tajanta Barojee s/o Ratan Banerjee (Mob. No. 9832466424) & Not known (5) Abhradey Satriadhar s/o Sattan Satriadhar (SADITAN SUTRADHAR) & Not known (Mob. No. 9083510842) (6) Prabhakar Mali s/o Sri Paritosh Mali of Not known (Mob. No. 9339650680), (7) Biki Sankar s/o Bijoy Sankar & Not known (Mob. No. 6297548335) (8) Rupak Das s/o Debkeemas Das & Not known (Mob. No. 8348420299) (9) Deep Mondal s/o Durlabh Mondal & Not known (Mob. No. 6295677255) (10) Ashoke Sankar s/o Sri Akhil Sankar of Shramik Nagar, North Charat Nagar, Ward no. 24 SMC, P.O. & P.S. Siliguri, Distt - Dajeeing (11) Khokan Das s/o Khagen Das of Birey more, Ward no. 36 SMC, P.S. N.T.P. Distt - Jalpaiguri, (Mob. No. 8597768652), (12) Not known s/o Not known & (13) Unknown s/o Not known, all are headed by said Bipan Das and when I came out at about 10:30 pm on said date, I found that my said E-Rikshaw, was missing from the parked place in front of Jaiswal Palace, Burdwan Road.

Sir, I had lost the Key of my said E-Rikshaw few days back and I used to start it sparking it with others and the above named/alleged Head & 12 other members of catering party, were aware of it and I have doubt that out of them, some people of stolen away my Tata Nabin Saha (Mob. No. 8942065362)
