⑤ That the said Susham Kela tried to touch one of my daughter in an inappropriate manner with the intention to touch her private parts and to disgrace her.

⑥ That we raised hue and cries and called out for help. Hearing this the above mentioned four people threatened us of dire consequence if in case we ask them to vacate the tenancy property. Susham Kela also threatened that he would kill my family and me wherever ever he finds us.

So, I request you to take strict action against the above named culprits.
