In producing herewith four (04) arrested accused persons namely (i) Md. Samreuddin(20), S/O- Md. Esmuddin of Lelin Colony, PO+PS- Matigara, Dist- Darjeeling, (ii)Bikash Mahato(26), S/O- Mangal Mahato of Hemanta Bose Colony, Ward No-04, PS-Siliguri, Dist- Darjeeling, (iii)Ranjan Chhetri(29), S/O- Raju Chhetri of Jyotinagar Colony, Ward No-04, PS- Siliguri, Dist- Darjeeling and (iv) Biswajit Mahanta(19), S/O- Krishna Mahanta of Khalaibakhtari, PO+PS- Matigara, Dist- Darjeeling ( not verified) arrested u/s-41 Cr.P.C along with following seized articles viz:

- (1) One iron made sword found from the possession of Bikash Mahato which was kept concealed on his back side.
- (2) One iron made 'Knife' found from the possession of Md. Samreuddin which was kept in his right hand.
- (3) One iron made 'Kukri' found from the possession of Ranjan Chhetri which was kept on his right hand.
- (4) One iron made Crowbars found from the possession of Biswajit Mahanta which was kept on his right hand.

I, PSI Shekhar Adhikary, S/O- Lt. Sonatan Adhikary of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (i) Md. Samreuddin(20), (ii)Bikash Mahato(26), (iii)Ranjan Chhetri(29), and (iv) Biswajit Mahanta(19) and others to the effect that today on 06.05.2022 at 01.45 hrs received a sources information that 14/15 youths have assembled at Paribahan Nagar back side of Uttorayan Dhaba under Matigara PS with a view to commit docoity in a house at Himachal Bihar area. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI Dhirendra Nath Mandal, ASI Tapan Das, C/1053 Poresh Rava, CV/387 Sukumar Barman left for the place to work out the information. At about 02.05 hrs. after reaching near Paribahan Nagar under PS- Matigara I met my source and being pointed by the source we started walking towards Paribahan Nagar, back side of Uttorayan Dhaba. At 02.15 hrs. we reached at Paribahan Nagar, back side of Uttorayan Dhaba and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from the spot seeing police personnel approaching towards them. They tried to flee away but on hot chase we managed to apprehend above noted four (04) accused persons along with seized articles as mentioned above. However, the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Himachal Bihar area.
