Respected Sir,

With due respect I, Sri.Kalachand Kundu, S/o. Late Saileshwar Kundu residing at Kundu Bhawan, Bidhan Road, Siliguri P.O & P.S. Siliguri, Dist. Darjeeling beg to state that I along with my own parents and brothers have been residing at Siliguri since 1969. In the year 1974 we acquired plots of land measuring about 43 acres in Village Chhobavita, Fulbari under present P.S. NJP Dist. Jalpaiguri for the purpose of tea factory and tea plantation.

After purchasing the land we have started tea plantation in and around the said plots of land under the name of "Kundu Family Tea Garden" and also, we have developed a Tea Factory namely "Gobra Agro Products Pvt Ltd". Since then, we are enjoying our title and possession peacefully without any interruption and have been running our business. We have also recorded the said plot of land in our names subsequently.

Recently we have decided to develop an Industrial Park and all the necessary formalities have been completed. We have also obtained the approval from the MSME Department Government of West Bengal under the scheme of SAIP for the proposed Industrial Park under the name "Jorapani Industrial Park". Since our State Government is giving thrust for Developing Industrial Park, under SAIP we are very much interested with this project. After completion of this project about 80 MSME Units will generate Investment of about 300 crores and employment of about 2500 persons directly.

We started our primary development work, like widening of the approach Road, Drainage, Boundary wall, etc. but we have been continuously facing disturbance from a group of land Mafias namely Rajesh Thirani & Anup Thirani S/o Durga Dutta Thirani of M.G. Marg Gangtok East Sikkim and Nitesh Lakhotia S/o Banwari Lal Lakhotia of Akhaytara Apartment Sevoke Road Siliguri.

They have also engaged **Sri Nagendra Nath Roy** residing at Chhobavita by paying a huge amount of money to him and to his Daughter **Rupali Roy** to grab our land.

They have fabricated some false documents more specifically for the year 1956 and 1961 and also managed to record in the name of aforesaid Lakhotia and Thirani on the strength of the false documents in connivance with the B.L & L.R.O department.
