Sir,

With due respect and humble submission I SI Sandip Dutta, O/C Milanpally OP under NJP PS, Siliguri Police Commissionerate submitted a written complaint against (i) Asnali Md., S/O - Not Known, (ii) Rosan Ali, s/o - Not Known, (iii) Mojarul Md., s/o - Not Known and 10/15 others including ladies of Mantadari Gate Bazar under Milanpalkly OP to the effect that today i.e. on 01/05/2022 at about 13:55 hrs in course of raid duty against Land broker received source information that one of the FIR named accused person namely Isanur Md., s/o - Asnali Md in c/w NJP P.S. Case No - 407/22, Dated - 30/04/2022, U/S - 447/325/385/506/307/120B IPC concealed himself at his house situated at Mantadari Gate Bazar under Milanpally OP. I then shared the information to O/C NJP PS and my Superior officers and as per their direction myself along with SI Kamal Sarkar, C/1052 - Dipak Das, C/445 - Dilip Roy, LC/1325 - Mamata Roy, NVF/159 - Debranjank Sarkar, CV/131 - Ranjan Kr. Sharma and CV/492 - Amulya Ghosh of Milanpally OP under NJP PS left OP to verify the veracity of information. This refers to Milanpally OP GDE No - 72, dated - 01/05/2022.

On arriving there at about 14.15 hrs I found the FIR named accused person namely Isanur Md., s/o - Asnali Md was sitting outside at his house. Accordingly our police team try to catch him but all of a sudden (i) Asnali Md., S/O - Not Known, (ii) Rosan Ali, s/o - Not Known, (iii) Mojarul Md., s/o - Not Known and 10/15 other people and including ladies restrained us to avoid the arrest of the FIR named accused person. Then the accused Isanur Md succeed to fly away from the spot. Finding no other alternatives I asked the above noted persons that why they restrained us to do our Govt. duty. Then the above noted accused persons including ladies threatened us in vernacular language. Then SI Kamal Sarkar and other police party interfered into the matter to maintain peace and public tranquility. But seeing police interfering the above noted all accused persons became furious and approached to the police party with a view to assault us and our 03 (three) Police personnel namely (i) CV/131 - Ranjan Kr. Sharma (ii) NVF/159 - Debranjank Sarkar (iii) C/1052 - Dipak Das received injuries on their persons and treated at Rajganj Rural Hospital, Jalpaiguri vide Reg. No - 3890, 3891, 3892, Dated - 01/05/2022 respectively. Seeing the gravity of the situation I informed the matter to O/C NJP PS as well as to superior. Being furious the above noted accused persons also voluntarily obstructing our public functions and also assaulted our police party and my associate police personnel from discharging my public duty as public servant. Finding no other alternatives myself along with officer and forces left the spot.
