With due respect, 1 am producing herewith 01 (One) arrested accused person namely Ananda Sarkar /(25 yrs) S/O Ganesh Sarkar of Kashmir colony, PS- NJP, Dist.- Jalpaiguri under arrest and 01 improvised small Fire arm (One shooter) measuring 28 cm in length including its 10 CM barrel with one trigger, striking hammer, striking pin in working condition loaded with 01 (one) round ammunition. The ground of arrest duly been communicated with him.

LASI Sojal Das of NJP PS, SPC do hereby lodge this written complaint against the above noted arrested accused person. In this regard, I beg to report that today i.e. on 02.05.22 at 06.05 hrs 1 received a secret information that one Ananda Sarkar [25 yrs] S/O Ganesh Sarkar of Kashmir Colony, PS- NJP, Dist.- Jalpaiguri is moving at Kashmir Colony play ground near party office under PS- NJP, Dist.- Jalpaiguri with improvised fire arms loaded with live ammunition most probably for committing heinous crime. Accordingly, I Diarised the information in General dinvy vide NJP PS GDE No 64 dated 02.05.2022 and informed the fact to you. As per kind order and direction myself along with VP/13 Jamirul Islam, CV/116 Rohit Mahata and CV/824 Niru Kumar Yaday all of NJP PS, SPC left for Kashmir colony play ground under PS-NJP, Dist.-Julpuiguri with investigation kit to work out the information in hand by Govt. vehicle. We reached at the spot i.e. Kashmir colony play ground at about 06.25 hrs on 02.05.22 and as indicated by the source we able to apprehend one dentity as noted above. As per source information, that he possessed improvised fire arms and ammunition. Hence, immediately I searched the detained person and recovered 01 (one) small Fire arm (One shooter) measuring 28 CM in length with one trigger, striking hammer, striking pin loaded with one ammunition which accused kept consealed in his waist. He possessed improvised fire arm loaded with ammunition illegally. On demand he produce any document in support the said improvised fire arm and live ammunition which has been found in his possession. Thus when his involvement in carrying and possessing illegal fire arm and ammunition was established, I seized that improvised fire arms and marked as "Exhibit-A" and 01 (one) round of ammunition marked as "Exhibit-B" under proper seizure list duly signed by him as well as by available witnesses between 06.40 hrs to 07.25 hrs on 02.05.22 and arrested him by preparing memo of arrest informing him about the ground of arrest.

Under the above noted facts and seizure of incriminating articles there is strong reason to believe that the said accused person namely Ananda Sarkar (25 yrs) S/O Ganesh Sarkar of Kashmr colony, PS- NJP, Dist.- Jalpaiguri is desperate and dangerous in nature, as he was carrying the said fire arm and ammunition with an objective to commit heinous crime in the

As he willfully violated the regulation of Arms Act, So, I pray before you for starting a locality. case against the said arrested accused person namely Ananda Sarkar (25 yrs) S/O Ganesh Sarkar of Kashur colony, PS- NJP, Dist.- Jalpaiguri under appropriate section of law and arrange for its investigation.
